## Lovisa Holdings Limited (LOV) - Results of 2022 Annual General Meeting

In accordance with ASX Listing Rule 3.13.2 and section 251AA of the Corporations Act 2001 (Cth), Lovisa Holdings Limited (ASX:LOV) advises the voting results of all resolutions and proxies received as set out in the attached proxy and voting summary. Resolutions 2, 3(a) and 3(b) were passed by way of a poll with the required majority of votes, however the outcome of Item 2 constitutes a second strike under the Corporations Act 2001 (Cth). As a result of the second strike against the remuneration report, Item 4 Contingent Spill Resolution was put to the meeting and defeated, therefore a separate Spill Meeting will not be required.
