## ***AIS Exercises Options and Increases Stake in iCandy***

Reference is made to iCandy Interactive Ltd's (ASX: ICI) ("**iCandy**" or the "**Company**") announcement dated 28 February 2022 regarding the completion of the acquisition of Digital Games International Pte Ltd (trading under the brand name "**Storms**") from Singtel, AIS and SK Telecom.

iCandy is pleased to announce that leading the Telco of Thailand, AIS has exercised its put option that allows iCandy to acquire an additional 16.3% stake in Storms from AIS for A\$2.61 million, which was settled via the issuance of 19,358,025 new iCandy shares at a **premium price** per share of A\$0.135 per new iCandy share. The new iCandy shares to be issued will be subject to voluntary escrow for 12 months from the date of issue.

Following the completion of the acquisition from AIS, iCandy's stake in Storms has increased from 67.3% to 83.7%. The remaining 16.3% stake in Storms is currently held by SK Telecom.

To recap, Storms is a mobile game developer and publisher with expansive distribution advantages due to its strategic partnerships with leading telcos and media companies. Storms' distribution channels will complement iCandy's strength in creating and developing AAA games, and is a key part of iCandy's roadmap to developing AAA games for the Metaverse and Web 3.0.

This announcement has been authorised by the Board of Directors of iCandy.
