

## Results of Loyalty Options Offer

Hydrix Limited (ASX:HYD) (**Hydrix** or the **Company**) is pleased to announce the successful completion of the Company's Loyalty Options Offer, as announced on 28 October 2022.

The Loyalty Options Offer, which closed at 5.00pm (Melbourne time) on Wednesday 30 November 2022, comprised the following offers:
