**QUARTERLEY ACTIVITY STATEMENT TO 31 DECEMBER 2022**

---

The Company advises its operational activities for the quarter to 31 December 2022 as follows;

**Sea Cucumber Project**

The Company wound back its operations and manufacturing in Japan during the quarter to save costs.

In December 2022 the Company placed its Japanese operations on hold for the balance of the northern winter as COVID continued to impact the manufacturing and distribution chains in Japan.

In the quarter the Company had small sales of its finished product in Japan.

**Blue Ocean Japan**

The Company continued to examine small scale renewal energy projects in Japan with a view to undertake an investment into such projects in quarters 3 and 4. Any investment remained subject to further funding which has not been agreed as at 31 Dec 2022.

**Bundybunna**

Despite the Company's best efforts to assist the termination of the liquidation of the Bundybunna Aboriginal Corporation Limited (in liquidation) (BbAC) no long term lease has been offered to the Company.

**General Investments**

Further discussions took place with a Singaporean investment fund and manager in respect to the Company investing along with fund, into renewal energy projects to be undertaken in Japan and Australia.

The Company has continued to discuss and negotiate an investment into Shopa Group in Australia. The Company is undertaking a due diligence examination of the Shopa Group. Any investment remains subject to funding which has not been agreed as at 31 Dec 2022. The Company is confident of securing funding for the investment if the due diligence examination into Shopa Group is satisfactory. The Company is seeking to undertake an investment in Shopa Group in quarter 4.

**Corporate**

The conversion of a secured loan to ordinary shares in the Company in a sum of \$2,000,000 took place in December 2022.
