iCandy Subsidiary Gameconomy Rebrands to Hashcode Studio

iCandy Interactive Ltd (ASX: ICI) ("**iCandy**" or the "**Company**") is pleased to announce that its subsidiary, Gameconomy Sdn Bhd has rebranded to Hashcode Studio Sdn Bhd ("**Hashcode Studio**").

Hashcode Studio, a boutique gaming software firm specialising in gaming technology, was acquired by iCandy in March 2022 for a consideration of MYR1.5 million (A\$497,264). Since then, Hashcode Studio has honed its specialisation in developing custom networking tools and game data management solutions, allowing it to grow into an industry-leading provider of metaverse-related technology.

For example, Hashcode Studio provides smart contract and integration solutions built on EVM-based chains such as Ethereum, Binance Smart Chain and Avalanche. The company is also actively expanding its development expertise into other chains such as Aptos and Polkadot.

The rebranding into Hashcode Studio signifies its continued ambition for quality Web3 backend solutions that will allow organisations from various industries to leverage the power of blockchain in their business operations.
