SHAPE delivers:

- **H1 FY23 revenue growth of 32%**
- **Underlying profit growth of 200%**
- **Statutory NPAT down 19%**
- **Interim dividend of 5 cents per share**

SHAPE Australia Corporation Limited (**ASX: SHA**) today reported a statutory and underlying **net profit after tax (NPAT) of \$4.7M** for the half year ended 31 December 2022, compared to \$1.6M underlying in H1 FY22, representing a 200% increase.

SHAPE's half-year results include:

- Revenue increased by 32% to a record result of \$436.3M
- Backlog Revenue of \$369.3M at 31 December 2022
- Underlying EBITDA up 108% to \$9.3M
- Net cash position increased by 19% to \$112.6M
- EPS of 5.6 cents increased by 194% on the underlying EPS of 1.9 cents
