### Resignation of UK auditor

**Structural Monitoring Systems Plc (“SMS” or “the Company”) (ASX: SMN)** wishes to advise that the Company was notified overnight by its UK auditor that they had been forced to resign from their engagement with the Company due to the unexpected departure, at very short notice of the audit partner responsible for the Group’s external audit function and a current lack of suitably experienced available replacement resources.

The attached letter of resignation from the UK auditor is attached by way of evidence.

As a result of this unexpected development, the Company’s Interim Report for December 2022 will not be reviewed and signed before the lodgement deadline today and the Company’s shares will be suspended from trading from tomorrow while we work to engage another suitably qualified UK registered auditor to review and sign the Company’s Interim Report.

We would like to advise that we have prepared everything required for the audit on schedule with the work reviewed by our auditor in Australia to their satisfaction, however we are required as a UK PLC to have the Interim Report reviewed and signed by a UK registered auditor before it can be lodged with the Australian Securities Exchange.

We are very disappointed that this situation, which is beyond our control, has occurred and are endeavouring to do everything possible to secure a suitably qualified replacement as soon as possible.

We look forward to updating the market regarding the appointment of a new auditor as soon as possible.
