### Chief Executive Officer - Resignation

Megaport Limited ACN 607 301 959 (**Megaport** or **Company**) (ASX: MP1) advises that the Company's Chief Executive Officer, Mr Vincent English, has tendered his resignation from the role, effective today. Mr English has also tendered his resignation as Executive Director of the Company, effective today. Mr English will remain available to advise and assist Megaport with transition until 30 April 2023.

Megaport's Chairman and Founder, Mr Bevan Slattery, said, "Vincent has provided outstanding leadership as CEO of Megaport for the past six years, leading the business through its scale up and scale out transformation. Vincent has been responsible for driving the vision of the Company through a period of incredible growth and for creating a legacy which sets the Company up for accelerated revenue growth and operational success in the future."

The board has commenced a global search for a new Chief Executive Officer. Mr Slattery has been appointed as the Interim Chief Executive Officer of the Company while the executive search is undertaken. Mr Slattery will remain in the role of company Chairman.
