BetMakers Technology Group Limited (ASX:BET) ("**BetMakers**" or the "**Company**") advises that today it has issued 822,533 fully paid ordinary shares ("**Shares**") upon the exercise of 666,666 performance rights and 155,867 service rights held by certain advisors and Directors of the Company following satisfaction of the relevant vesting conditions. Of the Shares to be issued:

- 124,587 Shares have been issued to non-executive Director, Anna Massion, on conversion
 of that number of service rights ¹; and
