Results of Annual General Meeting

25 May 2023 – Delta Drone International Limited (ASX: DLT) (DLT or the Company), a global drones-as-a-service provider, held its Annual General Meeting today, 25 May 2023 at 9.00am (WST).

The resolutions were voted in accordance with the Notice of Annual General Meeting and Addendum to Notice of Meeting, previously advised to the Australian Securities Exchange.

Resolution 2 (Spill Resolution) was withdrawn by the Chair as less than 25% of the votes cast on Resolution 1 were voted against the adoption of the Remuneration Report.

All remaining resolutions were passed on a poll, with the following resolutions passed by a sufficient majority as special resolutions:

- Resolution 5 - Approval of 7.1A Mandate
- Resolution 6 - Issue of Limited Recourse Loan Shares to Christopher Clark as a Director
- Resolution 7 - Issue of Limited Recourse Loan Shares to Paul Richard Williamson as a Director
- Resolution 13 - Change of Company Name
