### Entitlement Offer – correction to timetable

As announced on 19 June 2023, Toys'R'Us ANZ Limited (ASX: TOY) has commenced a non-renounceable entitlement offer of fully paid ordinary shares in TOY (**New Shares**) to raise a minimum of \$5,000,000, with a targeted raising of \$8,000,000 (**Entitlement Offer**).

Following the announcement, TOY has been notified of a required update to its timetable by ASX, relating to the timing for the allotment of New Shares. This is now reflected in the timetable below.
