#### **Notes**

- 1. Entire Notice: The details of the resolutions contained in the Explanatory Statement accompanying this Notice of Meeting should be read together with, and form part of, this Notice of Meeting.
- 2. Record Date: The Company has determined that for the purposes of the Extraordinary General Meeting, shares will be taken to be held by the persons who are registered as holding the shares at 7:00pm on the date 48 hours before the date of the Extraordinary General Meeting. Only those persons will be entitled to vote at the Extraordinary General Meeting and transfers registered after that time will be disregarded in determining entitlements to attend and vote at the Extraordinary General Meeting.

#### Proxies

- a. Votes at the Extraordinary General Meeting may be given personally or by proxy, attorney or representative.
- b. Each shareholder has a right to appoint one or two proxies.
- c. A proxy need not be a shareholder of the Company.
- d. If a shareholder is a company it must execute under its common seal or otherwise in accordance with its constitution or the Corporations Act.
- e. Where a shareholder is entitled to cast two or more votes, the shareholder may appoint two proxies and may specify the proportion of number of votes each proxy is appointed to exercise.
- f. If a shareholder appoints two proxies, and the appointment does not specify the proportion or number of the shareholder's votes, each proxy may exercise half of the votes. If a shareholder appoints two proxies, neither proxy may vote on a show of hands.
- g. A proxy form must be signed by the shareholder or his or her attorney who has not received any notice of revocation of the authority.
- h. To be effective, proxy forms must be received by the Company's share registry (Link Market Services Limited) no later than 48 hours before the commencement of the Annual General Meeting, this is no later than 10.00am (AEST) on Wednesday, 23 August 2023. Any proxy received after that time will not be valid for the scheduled meeting.

#### **Corporate Representative**

Any corporate shareholder who has appointed a person to act as its corporate representative at the Meeting should provide that person with a certificate or letter executed in accordance with the Corporations Act authorising him or her to act as that company's representative. The authority may be sent to the Company and/or registry in advance of the Meeting or handed in at the Meeting when registering as a corporate representative.

#### 5. How the Chair will vote Undirected Proxies

Subject to the restrictions set out in Note 6 below, the Chair of the meeting will vote undirected proxies in favour of all of the proposed resolutions. In exceptional circumstances, the Chair may change his or her voting intention on the Resolution, in which case an ASX announcement will be made. Shareholders may also choose to direct the Chair to vote against the Resolution or to abstain from voting.

#### 6. Voting Exclusion Statement:

#### Resolutions 1-3 & 7

The Company will disregard any votes cast in favour of these resolutions by or on behalf of any persons who participated or are expected to participate or who will obtain a material benefit as a result of the issue of securities or any associates of that person or those persons.

However, this does not apply to a vote cast in favour of these resolution by:

- a) a person as a proxy or attorney for a person who is entitled to vote on the resolution, in accordance with directions given to the proxy or attorney to vote on the resolution in that way; or
- b) the chair of the meeting as proxy or attorney for a person who is entitled to vote on the resolution, in accordance with a direction given to the chair to vote on the resolution as the chair decides; or
- c) a holder acting solely in a nominee, trustee, custodial or other fiduciary capacity on behalf of a beneficiary provided the following conditions are met:
  - (i) the beneficiary provides written confirmation to the holder that the beneficiary is not excluded from voting, and is not an associate of a person excluded from voting, on the resolution; and
  - (ii) the holder votes on the resolution in accordance with directions given by the beneficiary to the holder to vote in that way.

#### Resolution 4 to 6

The Company will disregard any votes cast in favour of each of Resolutions 4 to 6 (respectively and separately) by or on behalf of :

- Mr Stuart Rechner, Dr David DeTata and Mr Anthony McIntosh or any person(s) who will obtain a material benefit as a result of
  the proposed issue (except a benefit solely by reason of being a holder of ordinary securities in the entity), or
- an associate of person referred to in the preceding paragraph.

However, this does not apply to a vote cast in favour of the resolution by:

(a) a person as a proxy or attorney for a person who is entitled to vote on the resolution, in accordance with directions given to the proxy or attorney to vote on the resolution in that way; or

- (b) the chair of the meeting as proxy or attorney for a person who is entitled to vote on the resolution, in accordance with a direction given to the chair to vote on the resolution as the chair decides; or
- (c) a holder acting solely in a nominee, trustee, custodial or other fiduciary capacity on behalf of a beneficiary provided the following conditions are met:
  - i. the beneficiary provides written confirmation to the holder that the beneficiary is not excluded from voting, and is not an associate of a person excluded from voting, on the resolution; and
  - ii. the holder votes on the resolution in accordance with directions given by the beneficiary to the holder to vote in that way.

Furthermore, a vote must not be cast as proxy on any Resolutions 4 to 6 by a member of the Key Management Personnel (as defined by the Corporations Act) or a closely related party of Key Management Personnel.

However, a person described above (a "Restricted Voter") may cast a vote on any Resolutions 4 through to 6, as a proxy if:

a. The Restricted Voter is appointed as a proxy by writing that specifies the way the proxy is to vote on the Resolution(s); or

b. # **EXPLANATORY STATEMENT**

#### **Purpose of Information**

This Explanatory Statement ("Statement") accompanies and forms part of the Company's Notice of Extraordinary General Meeting ("Notice") for the Extraordinary General Meeting ("Meeting") will be held online, at 10.00am (AEST) on Friday, 25 August 2023.

The Notice incorporates, and should be read together, with this Statement.

# Background to Resolutions 1 to 7 (excluding resolution 2)

On 27 June 2023, the Company announced that it had raised \$2.5 million via a placement to institutional and sophisticated investors, The Placement will result in the issue of 178,571,428 fully paid ordinary shares at \$0.014 (1.4 cents) per share. The issue price represented a discount of 7% to the Company's last traded price prior to the Placement of \$0.015 immediately prior to the Placement.

The Placement of shares would be undertaken in two tranches. Tranche 1 resulted in 71,428,571 Shares being issued within the Company's existing placement capacity under Listing Rule 7.1 and 7.1A on Monday, 3 July 2023.

Tranche 2 is subject to shareholder approval and if approved will result in 107,142,857 Shares being issued. Each of the Directors have provided firm commitments to participate in the Placement subject to shareholder approval with approval sought under Resolutions 4-6.

Bell Potter Securities Ltd was sole lead manager and bookrunner to the Placement. The fees of the lead manager were 2% Management Fess plus 4% Selling Fees for proceeds raised from new shareholders. In addition, 3,000,000 unlisted Options at an exercise price of \$0.021 to be issued to the lead Manager subject to shareholder approval.

The two tranche Placement and associated resolutions are summarised below:

- Resolution 1 to ratify the issue of 71,428,571 shares under the Placement Tranche 1
- Resolution 3 to approve the issue of 97,571,429 shares under the Placement Tranche 2
- Resolutions 4-6 to the seek approval for the Directors to participate in the Placement on the same terms as the institutional and professional investors
- Resolution 7 to seek approval for the issue of 3,000,00 unlisted options to the lead manager in connection with the Placement

#### Resolution 1: Ratify the Prior Issue of Shares of a Placement

# Background

As noted above, the Company is seeking shareholder approval pursuant to ASX Listing Rule 7.4 to ratify the issue of 71,428,571 fully paid ordinary shares in the Company (Shares) on 3 July 2023 at an issue price of \$0.014 (1.4 cents) per Share on the terms as announced on 27 June 2023.

The Shares were issued without shareholder approval from the Company's 15% placement capacity pursuant to ASX Listing Rule 7.1 and 10% placement capacity pursuant to ASX Listing Rule 7.1A.

# **ASX Listing Rules**

ASX Listing Rules 7.1 allows the Company to issue new securities up to 15% of the existing capital of the Company in any 12-month period without the prior approval of Shareholders, excluding any issues that are subject to one of the exceptions in ASX Listing Rule 7.2 applies. The issue of the Shares was within the Company's available placement capacity under ASX Listing Rules 7.1.

ASX Listing Rule 7.1A provides that a Company may seek shareholder approval at its annual general meeting to issue additional guoted securities up to 10% of its issued capital, provided that it is an eligible entity (Eligible Entity).

An Eligible Entity is one that, as at the date of the relevant annual general meeting -

- a) it must have a market capitalisation of \$300 million or less.
- b) it must not be included in the S&P/ASX 300 Index.

At the time the approval was obtained (the Company's last Annual General Meeting 16 November 2022), the Company was an Eligible Entity.

Under ASX Listing Rule 7.4 an issue of securities will be treated as having been made with the approval of shareholders for the purposes of ASX Listing Rule 7.1 and 7.1A if the issue did not breach ASX Listing Rule 7.1 and 7.1A at the time and shareholders subsequently approve it. The issue of the Shares was within the Company's ASX Listing Rules 7.1 and 7.1A placement capacity and the Company now seeks Shareholder ratification of the issue pursuant to ASX Listing Rule 7.4 so as to refresh its capacity to make further issues (if required) without shareholder approval under Listing Rules 7.1 & 7.1A.

If this Resolution is approved, the prior issue of 71,428,571 Shares may be treated by the Company as having been made with Shareholder approval under ASX Listing Rule 7.1 & 7.1A. The Company will therefore have the flexibility, if required, to issue additional equity securities without the 71,428,571 Shares counting towards the 25% threshold for the purposes of ASX Listing Rules 7.1 & 7.1A.

If this Resolution is not approved, the prior issue of 71,428,571 Shares will not be treated by the Company as having been made with Shareholder approval under ASX Listing Rules 7.1 and 7.1A. The Company will therefore have the 71,428,571 Shares as counting towards the 25% threshold for the purposes of ASX Listing Rule 7.1 & 7.1A. This will limit the Company's placement capacity under the Listing Rule 7.1 & 7.1A.

ASX Listing Rule 7.5 requires that the following information be provided to Shareholders for the purpose of obtaining Shareholder approval pursuant to ASX Listing Rule 7.4:

- a) The Shares were issued to institutional and sophisticated investors, who are not related parties;
- b) the number and class of securities issued was 71,428,571 fully paid ordinary shares in the Company;
- c) the Shares were issued on 3 July 2023;
- d) the Shares were issued at a price of \$0.014 (1.4 cents) per Share; and
- e) the purpose of the issue was to raise fund for the diamond drill program and magnetotelluric (MT) survey at the Isa North Project in northwest Queensland, the diamond drill program at the Achilles Cu-Au Prospect in NSW and the MT survey at the Mundi project in NSW as well as working capital.

#### **Board Recommendation**

The Board recommends that shareholders vote in favour of Resolution 1.

The Chair of the Meeting intends to vote undirected proxies in favour of this Resolution.

Resolution 2: Ratify the prior issue of issue of 2,500,000 shares to Corporate Advisor

# **Background**

The Company is seeking shareholder approval pursuant to ASX Listing Rule 7.4 to ratify the issue of 2,500,000 fully paid ordinary shares in the Company (Shares) to Sternship Advisors Pty Ltd on 3 July 2023, as consideration for the provision of their service, on the terms as announced on 26 October 2022.

# **ASX Listing Rules**

ASX Listing Rules 7.1 allows the Company to issue new securities up to 15% of the existing capital of the Company in any 12-month period without the prior approval of Shareholders, excluding any issues that are subject to one of the exceptions in ASX Listing Rule 7.2 applies. The issue of the Shares was within the Company's available placement capacity under ASX Listing Rules 7.1.

Under ASX Listing Rule 7.4 an issue of securities will be treated as having been made with the approval of shareholders for the purposes of ASX Listing Rule 7.1 if the issue did not breach ASX Listing Rule 7.1 at the time and shareholders subsequently approve it. The issue of the Shares was within the Company's ASX Listing Rules 7.1 placement capacity and the Company now seeks Shareholder ratification of the issue pursuant to ASX Listing Rule 7.4 so as to refresh its capacity to make further issues (if required) without shareholder approval under Listing Rules 7.1.

If this Resolution is approved, the prior issue of 2,500,000 Shares may be treated by the Company as having been made with Shareholder approval under ASX Listing Rule 7.1. The Company will therefore have the flexibility, if required, to issue additional equity securities without the 2,500,000 Shares counting towards the 15% threshold for the purposes of ASX Listing Rules 7.1.

If this Resolution is not approved, the prior issue of 2,500,000 Shares will not be treated by the Company as having been made with Shareholder approval under ASX Listing Rules 7.1. The Company will therefore have the 2,500,000 Shares as counting towards the 15% threshold for the purposes of ASX Listing Rule 7.1. This will limit the Company's placement capacity under the Listing Rule 7.1.

ASX Listing Rule 7.5 requires that the following information be provided to Shareholders for the purpose of obtaining Shareholder approval pursuant to ASX Listing Rule 7.4:

- a) the Shares were issued to Sternship Advisors Pty Ltd;
- b) the number and class of securities issued was 2,500,000 fully paid ordinary shares in the Company;
- c) the Shares were issued on 3 July 2023;
- d) the Shares were issued as consideration for services provided and valued at \$0.02 (2 cents) each;
- e) the purpose of the issue was to compensate the Corporate Advisor, for the provision of services; and
- no funds were raised from the issue of securities.

#### Board Recommendation

The Board recommends that shareholders vote in favour of Resolution 2.

The Chair of the Meeting intends to vote undirected proxies in favour of this Resolution.

#### Resolution 3: Approval to issue of 97,571,429 shares as part of tranche 2 under Placement

#### **Background**

The Company is seeking Shareholder approval pursuant to ASX Listing Rule 7.1, to allot, 97,571,429 fully paid ordinary shares in the Company at \$0.014 (1.4 cents) per share, as part of the tranche 2 placement of Shares, announced on 27 June 2023 to institutional and sophisticated investors under the Placement.

A further 9,571,428 Shares are to be issued to Directors on the same terms and approval for those issues is sought under resolutions 4 through to 6.

# **ASX Listing Rules**

ASX Listing Rule 7.1 provides that a company must not, without shareholder approval, issue or agree to issue more securities during any 12 month period than that amount which represents 15% of the number of fully paid ordinary securities on issue at the commencement of that 12 month period. As the issue of 97,571,429 fully paid ordinary shares, without shareholder approval, exceed that 15% limit, the Company proposes Resolution 3 to seek shareholder approval under Listing Rule 7.1.

If Resolution 3 is passed, the Company will issue the 97,571,429 fully paid ordinary shares without using any of its placement capacity under Listing Rule 7.1, retain the flexibility to make future issues of equity securities up to the 15% limit and raise approximately \$1,366,000 before issue costs. If Resolution 3 is not passed, the Company will not be able to issue the 97,571,429 Shares under the Placement.

ASX Listing Rule 7.3 requires that the following information be provided to Shareholders for the purpose of obtaining Shareholder approval pursuant to ASX Listing Rule 7.1:

- a) The Shares will be issued to institutional and sophisticated who are not related parties;
- b) the number and class of securities issued was 97,571,429 fully paid ordinary shares in the Company;
