

MARKET UPDATE FOR QUARTER ENDED 30 JUNE 2023

BauMart Holdings Limited (ASX: BMH) (“BauMart” or the “Company”) is pleased to present its quarterly cash report and operational update to 30 June 2023.

Group Results and Commentary on Appendix 4C

- During the quarter, the Company received inflows totalling \$113K comprised of customer receipts for mining consumables and pre-orders for natural stones.
- Company expenditure for the quarter increased slightly due to onboarding of a new employee, with staff costs totalling \$72K for the June quarter.
- Payments to Related Parties of the Company and their associates, comprised of executive director salaries and non-executive directors’ fees, came up to \$60K for the quarter.
- Directors to continue to monitor corporate overheads with the aim of allocating capital towards ongoing strategic objectives, including future orders of mining equipment.

Source & Procure Division

- Management is pleased to advise that recurring orders for mining consumables and natural stones were placed during the quarter.
- The Company continued to invest time and resources during the quarter towards growing the pipeline and strengthening supplier relationships, and management recently visited the key supplier in China.
- Management to continue to explore opportunities within its network of customers and suppliers, in addition to progressing the orders pipeline for mining equipment and consumables.

Other Activities

- Recent activities for the Washpod product included a sale and leaseback arrangement for several rented machines, which allowed the Company to access additional funds of approx. \$63K, and meeting with overseas partners to progress discussions on the distribution network for new markets.
- The Board remains committed to reviewing growth opportunities, with a focus on margin expansion and new revenue streams.
