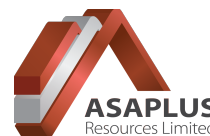

## QUARTERLY ACTIVITIES REPORT FOR THE QUARTER FROM 1 APRIL 2023 TO 30 JUNE 2023 (THE “REPORTING QUARTER”)

1. Works at the Beikeng Mine
  - 1.1. Completed drilling of eight drill-holes in the pit below the No. 650 middle section of Beikeng Iron Mine, drilling depth was 403.10 metres, and carried out testing of the core samples from those drill-holes.
  - 1.2. Submitted the Company's mine development plans for registration with the Municipal Green Mine Database. Having passed the site's initial review by the Natural Resources Departments at the county and city levels, the Company's registration submission has been approved.
  - 1.3. Completed the declaration of the use of the geological environment and ecological restoration fund and the calculation of the restoration fund in 2023, passed the GNSS site inspection and rectification of provincial mine geological environment in 2023.
  - 1.4. The Company's blasting technicians completed their continuing education and training and renewed their qualification registration for 2023.

## 2. Exploration Expenditure Incurred

Total expenditure incurred and paid for activities classified as exploration and investigation works carried out during the Reporting Quarter was A\$nil.

The mining tenements held at the end of the quarter and their location

The Beikeng Mine, a 0.771 km<sup>2</sup> iron ore tenement located in Datian County, Sanming City, Fujian Province in the People's Republic of China, under extraction licence number C3500002010122110086857 which expired on 4 February 2023. The Company is currently in the process of applying for an extension of the extraction licence. During this period, the Company is permitted to carry on its operations. Barring any unforeseen circumstances, the Company believes the extraction licence will be granted. The Company holds an 84% interest in the Beikeng Mine.

The Silverstone Project, a 4.83 km<sup>2</sup> tenement located in Datian County, Sanming City, Fujian Province in the People's Republic of China, under exploration licence number T35120110102043628 which expired on 30 October 2014. The Company has applied to the relevant authorities for an extension of time to apply for the renewal of this exploration permit. As the Company does not have any immediate plan to commence commercial operations at the Silverstone Project, the Company will only apply for the extension of the exploration permit (as a precursor for the Company to complete its application for an extraction licence) at such time when demand for and prices of iron ore make it feasible to commence commercial operations at the Silverstone Mine.


