Respiri completes private placement of new ordinary shares

Respiri Limited (ASX:RSH; OTCQB:RSHUF) ("Respiri" or the "Company"), an eHealth SaaS Company supporting respiratory remote patient monitoring, is pleased to announce that the Company has completed a A\$0.9m private placement of new ordinary shares, that is in addition to the previously announced A\$3M Share Purchase Plan ("SPP") Offer announced and completed on 8 August 2023. The Company welcomes the continued support of its existing shareholders and incoming investors.

The proceeds from the combined capital raise (SPP Offer and private placement) will be primarily used to fund the strategic acquisition of Access Managed Services LLC (Access), working capital for US commercialisation acceleration and the subsequent 3-month tranche of the Access acquisition.

The placement of 26,470,588 new ordinary shares is at an issue price of A\$0.034 per Share and one (1) free attaching Option for every two (2) Shares subscribed for, each exercisable at \$0.065 and expiring 30 June 2025, with such Options to be quoted on ASX. The placement has been made to existing and new investors and not to related parties of the Company.

Nicholas Smedley, Respiri Chairman said "Our Shareholder and new investor support is a clear endorsement of the Company's strategy to drive recurring revenue from the very attractive US remote patient monitoring market. The Access acquisition and wheezo® device differentiation underpin this success with commercially significant milestones anticipated to be achieved in the second half of 2023."
