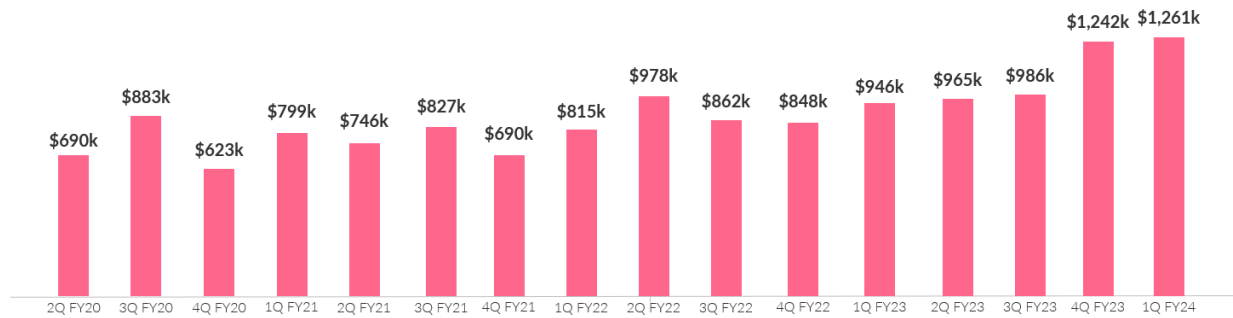
## Love Group reports first quarter FY24 results

- **Quarterly customer cash receipts of \$1,261k and net operating cash outflow of \$69k**
  - Quarterly customer cash receipts of \$1,261k, up 2% quarter-on-quarter and up 33% year-on-year
  - Ending quarterly cash balance of \$2,035k, a decrease of \$57k quarter-on-quarter as a result of net operating cash outflow of \$69k, and FX impact of \$12k
  - Quarterly expenditure was in line with internal budgets and was focused on the following areas:
    - Advertising and marketing expenditures of \$388K
    - Staff costs including salaries and commissions of \$633K
- **Quarterly customer cash receipts by city**
  - **Hong Kong:** \$832k quarterly customer cash receipts, down 7% quarter-on-quarter versus \$893k in the previous quarter, driven by lower average order value
  - **Singapore:** \$391k quarterly customer cash receipts, up 26% quarter-on-quarter versus \$310k in the previous quarter, driven by higher consultation volume
  - **Bangkok:** \$37k quarterly customer cash receipts, down 5% quarter-on-quarter versus \$39k in the previous quarter, driven by lower consultation volume
- **Near-term growth drivers**
  - Grow Lovestruck personal matchmaking business in existing markets of Hong Kong, Singapore and Bangkok
  - Expand Lovestruck personal matchmaking business into London
  - Launch new online dating business with new online dating app to target singles seeking serious committed relationships, with an initial launch in Hong Kong

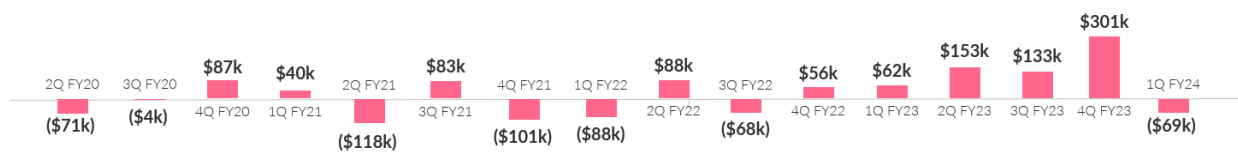

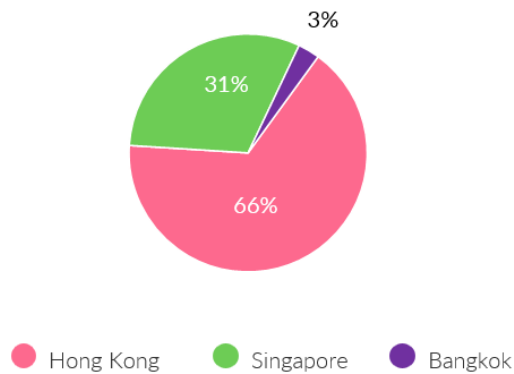
Customer cash receipts

**Love Group Founder and CEO, Michael Ye:** *“Our business continued to see strong growth in the first quarter of fiscal year 2024, with our customer cash receipts growing by 33% year-on-year to \$1,261k. Our strong financial results were underpinned by strong revenue growth in Singapore, where we saw a notable increase in consultation volumes as a result of our new marketing initiatives. Looking ahead, we are excited about the upcoming launch of our new online dating app in Hong Kong, as well as expanding our Lovestruck personal matchmaking business into London, one of the largest markets in the world for matchmaking services for singles.”*
