Answer: The Company expects expenditure in the December quarter to be materially reduced from previous quarters given the conclusion of the initial Bynoe drilling campaigns. The Company therefore expects net operating cash flows to be higher in the December quarter than previous quarters

Answer: The Board is aware of the current cash position and will take the appropriate steps when required, whether that be raising equity capital or other strategic solutions. Based on a history of successful past capital raises (through a placement in 2022 and an IPO in 2021), the Board is confident such steps will be successful.
