	<p>Answer:</p> <p>The Company has been able demonstrate a record of securing funds when required and is confident that it will continue to do so. The Company lodged a prospectus with the ASX and ASIC on 13 October 2023 to raise a total of \$5.5m (before costs) via a public offer and priority offer. On 19 October 2023 the Company announced the early close of the public offer raising \$3.5m (before costs). On 31 October 2023 the Company announced completion of the priority offer raising \$0.6m (before costs). Company Directors have applied for a further \$245,000 subject to shareholder approval at the Company's AGM to be held on 22 November 2023.</p>
