Results of 2023 Annual General Meeting

The results of the resolutions put to the Qantas Airways Limited (Qantas) Annual General Meeting held on 3 November 2023 are set out in the attached document.

All resolutions were decided by way of poll and were passed as ordinary resolutions, with the exception of Resolution 4 which was not passed.

As more than 25% of the votes cast on Resolution 4 were against the adoption of the 2023 Remuneration Report, this constitutes a 'first strike' for the purposes of the Corporations Act 2001 (Cth).
