

VIKING DELIVERS 103% GROWTH AT CANEGRASS WITH 2.2 BILLION LBS OF VANADIUM PENTOXIDE

- Viking has completed an updated JORC (2012) Mineral Resource Estimate (MRE) report for the Canegrass Battery Minerals Project (the Project).
- MRE grows 103% and now contains >2.2 Billion Pounds of the critical mineral Vanadium Pentoxide (V_2O_5).
- Total Inferred MRE for the Project:
 - 146Mt at 0.70% V₂O₅, 31.8% Fe & 6.6% TiO₂ (>0.5% V₂O₅ cut-off)
- High-grade subset of the MRE provides the basis to commence a Scoping Study to assess Project options:
 - 27.5Mt at 0.87% V₂O₅, 37.3% Fe & 8.0% TiO₂ (>0.8% V₂O₅ cut-off)
- Thick zones of high-grade mineralisation >0.8% V₂O₅ commence from surface indicating potential for a low strip-ratio mining operation.
- Maiden estimate for copper, nickel & cobalt at the Project, delivering:
 - 146Mt at 0.066% Cu, 0.062% Ni & 0.016% Co (>0.5% V₂O₅ cut-off).
 - Total metal content of 97Kt Cu, 90Kt Ni & 23Kt Co
 - Metallurgical testwork planned to assess process options for these additional valuable metals.
- Applying metallurgical testwork results to the high-grade subset of the MRE indicates the potential to deliver >16Mt concentrate at a grade of >60% Iron.¹
- The opportunity to produce a direct ship concentrate with credits for Iron and Vanadium to be investigated.
- Viking to commence with preliminary activities ahead of Scoping Study.

Viking Mines Ltd (ASX: VKA) ("**Viking**" or "**the Company**") is pleased to provide an update on the highly anticipated Mineral Resource Estimate ("**MRE**") for the Canegrass Battery Minerals Project ("**the Project**" or "**Canegrass**"), located in the Murchison region of Western Australia.

The MRE has proven highly successful, with a 103% increase in the contained V_2O_5 to 2.2 Billion Pounds within the total MRE (>0.5% V_2O_5) of 146Mt at 0.70% V_2O_5 , 31.8% Fe & 6.6% TiO₂. Significantly, a **high-grade subset of the MRE contains 27.5Mt at 0.87% V_2O_5**, providing the basis to move forward and commence with a Scoping Study on the Project.

The opportunity to produce a direct ship Iron Ore concentrate from the Project with credits for Vanadium content to be investigated by the Company.

Viking Mines' Managing Director & CEO, Julian Woodcock, said:

"I am extremely pleased with the outcome of the MRE. The Company identified the opportunity at Canegrass with the presence of outcropping mineralisation throughout the tenure which was not included in the 2017 MRE inherited with the Project.

"Not only is it a significant achievement that we have more than doubled the contained Vanadium within the Deposit, but more importantly we have identified and defined a substantial high-grade portion of 27.5Mt at 0.87% V_2O_5 which will form the basis for commencing a Scoping Study.

"With the positive results from the metallurgical testwork completed earlier this year that produced a magnetic concentrate >60% Fe¹, we can now investigate the opportunity to produce a magnetite concentrate suitable for direct shipping.

"Combined with the first estimates for Cu, Ni and Co, this provides additional optionality for Viking to assess multiple pathways to release the huge inherent value in this large multicommodity Resource."




Figure 1; Map of the Canegrass Project showing the JORC (2012) MRE for each of the deposit areas and the total combined estimate. Note all Resources are Inferred category reported above a 0.5% V₂O₅ cut-off. Totals may vary due to rounding.



CANEGRASS PROJECT MINERAL RESOURCE ESTIMATE

Industry consultants, MEC Mining have completed the MRE update for Viking Mines Canegrass Project. The MRE update is the product of the extensive exploration campaign undertaken by Viking since announcing acquisition of the Project in November 2022.

The MRE has determined a significant increase at the Project over the previous estimate reported by Red Hawk Mining in 2017.² Table 1 below provides the summary of the MRE and comparison to the previous estimate.

The tonnage has increased substantially, with improvements in grade for all the target commodities. Further, the grade of the deleterious elements has decreased, which results in a higher quality ore more amenable to processing to produce a magnetic concentrate.

Table 1; 2023 Canegrass Project MRE update and comparison to 2017 model showing substantial growth in tonnes and grade of the primary commodities (reported above a 0.5% V₂O₅ cut-off). Note, Cu, Ni & Co were not estimated for the Project in 2017.

	This high-grade subset of the MRE will form the basis for Vikings future work to assess the economic viability of the Project and aligns with the Company's aspirations to become a 15-20 year mine life operator processing 1.5-2.0Mtpa.													
	Most significantly is a high-grade subset of the MRE when reported above the higher cut-off of $0.8\% \ V_2O_5$. This cut-off has been selected as it represents the change from disseminated magnetite in gabbro to massive magnetite bands seen in the drilling data and forms continuous zones which the Company believe could be amenable to mining.




Figure 3; Cross-section through the Fold Nose Deposit looking to the NE showing the distribution of high-grade zones within the broader mineralised package. Note mineralisation extends from surface to depth with over 460m dip continuity and thicknesses up to 30m.




Figure 2; Cross-section through the Kinks Deposit looking to the West showing the distribution of high-grade zones within the broader mineralised package. Note mineralisation extends from surface to depth with over 390m dip continuity and thicknesses up to 28m.






Figure 4; Cross-section through the Kinks South Deposit looking to the West showing the distribution of high-grade zones within the broader mineralised package. Note mineralisation extends from surface to depth with over 280m dip continuity and thicknesses up to 31m.

Target Commodities & Mineral Content

The primary target commodities for the Project are Vanadium (as V_2O_5), Iron, Titanium (as TiO_2), Copper, Nickel and Cobalt. The MRE has resulted in substantial quantities of these valuable minerals being defined. Table 3 & Table 4² provide a summary of the contained commodities within the MRE at the stated cut-off grades. The tonnage and grade values used to determine these mineral quantities are provided in the tables above.

GROWTH POTENTIAL




Figure 5; Map of the Fold Nose Deposit with 2023 MRE limits shown and target areas for further growth of the MRE illustrated.






Figure 6; Map of the Kinks Deposit with 2023 MRE limits shown and target areas for further growth of the MRE illustrated.




Figure 7; Map of the Kinks South Deposit with 2023 MRE limits shown and target areas for further growth of the MRE illustrated.

With the extensive drilling completed by the Company and the completion of the MRE, areas for further growth have been identified at each of the three deposits (Figure 5, Figure 6 & Figure 7). This provides further upside opportunity to both increase the tonnes and grade of the high-grade subset of the total MRE.

With further drilling in these areas, it is anticipated that the total high-grade subset will grow and exceed the Company's target of >30Mtand commensurate growth of the total MRE >0.5% V₂O₅ cut-off will likely occur as a byproduct of this work.

Drill programmes to test these areas will be investigated by the Company as part of future work programmes.

FORWARD STRATEGY

With the high-grade subset of the total MRE reaching close to our aspirational target of 30Mt >0.9% V₂O₅, the Company is now focussed on determining the most effective method to release the high inherent value of the Project.

Further metallurgical testwork has commenced with the objective of producing V_2O_5 flake as an end product suitable for sale from the Project. This testwork will also further evaluate the mineralisation and its suitability to produce a marketable Iron Ore concentrate. The benefit of this approach is that a much lower capital cost project could be undertaken to produce a magnetic concentrate which could be direct shipped to offtake partners.

In addition to investigating the metallurgy and potential of offtake partners for product from the Project, the Company will commence with initial economic assessments with a pit optimisation study. This is a key pre-cursor to commencing a Scoping Study as it will define an indication of the size of operation which could be supported by the updated MRE. Discussions have commenced with MEC Mining to undertake this work.

In parallel with the pit optimisation study, the Company will also commence determining the key steps required to complete a Scoping Study on the Project.

These next stage work programmes will collectively identify the economic potential of the project.

MINERAL RESOURCE ESTIMATE – MATERIAL INFORMATION SUMMARY

Viking Mines engaged industry consultants MEC Mining to undertake a Mineral Resource Estimate (MRE) for the Canegrass Battery Minerals Project.

The MRE incorporates 3 deposits called Fold Nose, Kinks and Kinks South, with estimates completed for the following: V_2O_5 , Fe, TiO_2 , Cu, Ni, Co, SiO_2 , Al_2O_3 , P, LOI, and Density.

A summary of sampling techniques and data, and estimation and reporting methodologies is contained in JORC Table 1 which is included as an attachment to this ASX release.

The Resource is reported above the 210 m RL, which effectively removes all blocks at a depth greater than 250 m below surface. MEC Mining consider that this approach results in a Mineral Resource Estimate which appropriately and transparently addresses the "Reasonable Prospects for Eventual Economic Extraction" requirement for Mineral Resources reported under the JORC Code (2012 Edition) with regards to mining potential.

Geology and Geological Interpretation

All domains were defined using a combination of grade, primarily vanadium, titanium, and iron; magnetic susceptibility, density, and lithology. Domains were modelled on the basis that the deposits were formed from differentiation of layers in the magma chamber melt and were subsequently folded. An implicit model was used to guide the explicit modelling. All MRE were reported above an economic cut-off grade of $0.5\% \, V_2 O_5$, no top cuts were applied as no extreme values that could bias the estimation were observed.




Figure 8; Plan view of Kinks South wireframes – Wireframe colours by sub-domains with the main domain coloured purple which provides the largest contribution of mineralisation to the final MRE statement >0.5% V₂O₅.




Figure 9; Plan view of Fold Nose Deposit wireframes – Wireframe colours by sub-domains with the main domain coloured orange which provides the largest contribution of mineralisation to the final MRE statement >0.5% V₂O₅.




Figure 10; Plan view of Kinks wireframes – Wireframe colours by sub-domains with the main domain coloured orange which provides the largest contribution of mineralisation to the final MRE statement >0.5% V₂O₅.

The final wireframes constructed for each of the three deposits and coloured by domain are shown in plan view below for the Kinks South area (Figure 8), the Fold Nose area (Figure 9) and the Kinks area (Figure 10).

Sampling and Sub-Sampling Techniques

Reverse circulation ("**RC**") drilling was the primary sampling method, with lessor diamond (NQ2 size) drilling. Cone splitters were used for sampling 1m intervals during RC drilling programmes with the 2m and 4m composite samples obtained by spear or scoop sampling of bags.

Diamond core was cut in quarter with a core saw and sampled at variable intervals. RC recoveries were reported as all very good based on visual estimates but not quantified. The diamond recoveries reported as excellent but not quantified.

Samples were then sorted, dried and weighed at the laboratory. The whole sample was then crushed, and split with a riffle splitter to collect a sub-sample, which was then pulverised using a vibrating pulveriser.

Drilling Techniques

One hundred and five (105) drill holes for 15,833m were used for the MRE; inclusive of 102 Reverse Circulation (RC) drillholes for 14,978m, and 3 Diamond drill holes for 678m. Drillhole depths range from 7m to 500.7m. Viking drilled 43 drillholes for 7,104m, 45% of the total 15,833m.

- Fold Nose has 47 drillholes for 7,426.7m; inclusive of 46 RC drill holes for 6,926m, and 1 Diamond drillhole for 500.7m. Viking Drilled 17 holes for 2,768m which is 37%, and Historic drilling is 30 drillholes for 4,658.7m which is 63%.
- Kinks South has 34 drillhole for 4,578.3m; inclusive of 2 Diamond drillhole for 177.3m, and 32 RC drillholes for 4,401m. Viking Drilled 19 drillholes for 3,237m which is 71%, and Historic drilling is 15 holes for 1,164.3m which is 29%.



• Kinks has 24 drillholes for 3,828m. All Kinks drillholes are RC. Viking Drilled 7 holes for 1,099m which is 29%, and Historic drilling is 17 drillholes for 2,729m which is 71%.

The drillhole spacing at Fold Nose varies from $100m \times 50m$ to $300m \times 100m$. The drillhole spacing at Kinks South varies from $50m \times 100m$ to $300m \times 100m$. The drillhole spacing at Kinks varies from $100m \times 100m$ to $300m \times 150m$.

Classification Criteria

The Mineral Resource has been classified in accordance with guidelines contained in the JORC Code (2012 Edition). Data quality, data distribution, and the geological and grade continuity at the project were considered prior to forming a judgement on Mineral Resource confidence. Following consideration of these aspects, Fold Nose, Kinks South and Kinks Mineral Resources were classified as Inferred.

Sample Analysis Method

The majority of samples used to estimate the Mineral Resource were derived from drilling completed by Maximus Resources, Flinders Mines (now Red Hawk Mining) and Viking Mines.

Theses samples were submitted to laboratories in Perth for analysis. A prepared sample is fused using a 12:22 lithium tetraborate – lithium metaborate flux to form a glass bead then determined by x-ray fluorescence (XRF). Loss on ignition results were determined using a robotic TGA system. Furnaces in the system were set at 425, 650 and 1000° C. Samples were analysed by XRF for 21 elements including V, Fe, TiO₂, Cu, Ni, Co, SiO₂, Al₂O₃, P and LOI, in addition to other constituents that weren't estimated. The techniques are considered total.

Estimation Methodology

Assays were composited to 1m. The geology model wireframes were assigned to the assay file. The grades within the wireframes were then used to model experimental variograms using two components and spherical variogram models.

The Ore Block Model parent blocks were 20m x 20m east/west and north/south and 5m in elevation, subcelled to 2m x 2m east/west and north/south and 1m in elevation. All blocks were restricted to the geological wireframes.

Only those composited sample intervals which occur within the wireframed mineralisation were used to interpolate grades into the block model, using ordinary block kriging, with discretisation of 2 x 2 x 2 to partially address change of support issues. Negative kriging weights were reset to zero and subcells were estimated to obtain resolution of estimation as the narrow geometry of the lodes did not permit estimation to parent cells only.

The Fold Nose MRE were estimated using flattening and extension to allow for the training of the search ellipse to include all relevant samples. The Kinks South and Kinks MRE were not unfolded or flattened as they were linear.

Experimental semivariograms were modelled for:

- Vanadium (with cobalt, copper and nickel using these variogram parameters for the estimation of these elements);
- Iron (with LOI, phosphorous, silica, and alumina using these variogram parameters for the estimation of these elements); and
- Titanium.

Search ellipse distances were defined initially from the semivariogram range distances and were then increased to ensure all blocks were populated. Search ellipses used a minimum of



three drillholes for Run 1 to avoid isolated estimation of blocks. The search ellipse dimensions were increased for Run 2 to populate all remaining blocks.

Some lodes included assay results for commodities such as Vanadium but did not include LOI and other variables. As such, the average interpolated grade for the variable being estimated was defaulted to blocks within the OBM which were not interpolated due to the absence of values. This occurred for LOI in all three deposits and for SiO_2 in the Kinks deposit.

Cut-off Grades

A cut-off grade of 0.5% V_2O_5 has been applied when reporting the Mineral Resource. A 0.5% V_2O_5 cut-off grade is within the range adopted for reporting Mineral Resources at other Australian VTM deposits for planned open cut operations.

Modifying Factors^{1,3}

Davis Tube Recovery (DTR) test work has been completed at the Project, with the most recent work completed by Viking on samples collected from the Kinks South Deposit. Results have demonstrated that a magnetic concentrate can be produced with the Vanadium, Iron and Titanium reporting to the concentrate. Recoveries over 90% vanadium reporting to the magnetic concentrate were achieved. Further testwork is required to demonstrate that a Vanadium Pentoxide flake product can be produced and is currently underway on samples collected from the Fold Nose deposit.

Reasonable Prospects Hurdle

Clause 20 of the JORC (2012) Code requires that all reports of Mineral Resources must have reasonable prospects for eventual economic extraction, regardless of the classification of the resource.

MEC Mining deems that there are reasonable prospects for eventual economic extraction using open pit mining on the following basis:

- The Canegrass lodes outcrop or occur close to surface and will be amenable to opencut mining to commence production.
- A restriction of depth to 210 m RL was applied to all MRE that are prospective for opencut mining, correlating with an average depth of 250m, which may be confirmed by recommended pit optimisation studies.
- The Canegrass Mineral Resource occurs within a prolific Vanadium region with several projects in a pre-operations phase, there is strong nearology, and extensive infrastructure.
- The Canegrass project is 60km from the township of Mount Magnet, with sealed airstrip & regular commercial flights. There is a bitumen road to within 22km of the Canegrass project. The Midwest gas pipeline passes 22km north of the Project. The Canegrass project is 419km from an established Port at Geraldton already used to export iron ore and mineral sands.
- The metallurgical testwork completed to date demonstrates that a magnetic concentrate can be produced from the Project which indicates the potential to deliver a marketable product.
- A cut-off grade of 0.5% V₂O₅ has been applied when reporting the Mineral Resource. A 0.5% V₂O₅ cut-off grade is within the range adopted for reporting Mineral Resources at other Australian VTM deposits for planned open cut operations.

• Demand for vanadium is likely to increase in the future, particularly given potential battery applications.

NEXT STEPS

With the completion of the MRE and the substantial increase in both the quantity and quality of the Resource, the Company has achieved a significant milestone, less than 12 months since acquiring the Project. Work continues to advance the Project forward with the following key items underway:

- Second stage metallurgical testwork underway to produce V_2O_5 flake and demonstrate a saleable product for offtake discussions.
- Undertake a preliminary pit optimisation study to assess the potential production opportunities and to feed into key objectives for a Scoping Study.
- Further assessment of magnetic concentrate products to review options for a direct ship iron ore product with vanadium credits.
- Engage with potential offtake partners and commence discussions on marketing of Canegrass concentrate.

CANEGRASS BATTERY MINERALS PROJECT

The Canegrass Battery Minerals Project is located in the Murchison region, 620km north-east of Perth, Western Australia. It is accessed via sealed roads from the nearby township of Mt Magnet to within 22km of the existing Resources. The Project benefits from a large undeveloped Inferred Vanadium Resource hosted in vanadiferous titanomagnetite (VTM) Mineralisation as part of the Windimurra Layered Igneous Complex.

The Project benefits from ~95km² of exploration tenements with very limited follow up exploration targeting the growth potential of the vanadium pentoxide (V_2O_5) Resources in the +10 years since the Resource was first calculated. Multiple drill ready targets are present which have the potential to significantly add to the already large Resource base, with high grade intercepts presenting an opportunity to substantially increase the average grade.

JORC (2012) MINERAL RESOURCE

The Canegrass Mineral Resource has been calculated across three separate areas called the Fold Nose, Kinks and Kinks South deposits, each with. The Resource has subsequently been reported above a cut-off grade of 0.5% V_2O_5 and above the 210 RL (equivalent to a maximum depth of ~ 250 m).

As of August 2023, Viking has completed the first stage of the Farm-In and acquired a 25% equity interest in the tenements hosting the Deposits.



VANADIUM REDOX FLOW BATTERIES - GREEN ENERGY FUTURE

Viking Mines recognise the significant importance of Vanadium in decarbonisation through the growth of the Vanadium Redox Flow Battery ("**VRFB's**") sector.




Figure 11; Forecast growth of the VRFB Sector through to 2031 (source - Guidehouse Insights)

VRFB's are a developing market as an alternate solution to lithium-ion ("**Li-ion**") in specific large energy storage applications. Guidehouse Insights Market Intelligence White Paper published in 2Q 2022 forecasts the VRFB sector to grow >900% by 2031 through the installation of large, fixed storage facilities (Figure 11).

Annual Installed VRFB Utility-Scale and Commercial and Industrial Deployment Revenue by Region, All Application Segments, World Markets: 2022-2031

The reason for this forecast growth is that VRFB's have unique qualities and advantages over Li-ion in the large energy storage sector to complement renewable energy sources to store the energy produced. They are durable, maintain a long lifespan with near unlimited charge/discharge cycles, have low operating costs, safe operation (no fire risk) and have a low environmental impact in both manufacturing and recycling. The Vanadium electrolyte used in these batteries is fully recyclable at the end of the battery's life.

Importantly, and unlike Li-ion, the battery storage capacity is only limited by the size of the electrolyte storage tanks. This means that with a VRFB installation, increasing energy storage capacity is only a matter of adding in additional electrolyte (via the installation of additional electrolyte storage tanks) without needing to expand the core system components. Increasing the energy storage directly reduces the levelized cost per kWh over the installation's lifetime. This is not an option with Li-ion batteries.

It is for these reasons that VRFB's are an ideal fit for many storage applications requiring longer duration discharge and more than 20 years of operation with minimal maintenance.
