Upcoming Release of Securities from Escrow

Hydration solutions company **The Hydration Pharmaceuticals Company Limited (ASX: HPC)** ("Hydralyte North America" or "the Company") wishes to advise that in accordance with ASX Listing Rule 3.10A:

- 6,671,720 fully paid ordinary shares will be released from voluntary escrow on 13 December 2023; and
- 885,625 fully paid ordinary shares will be released from voluntary escrow on 14 December 2023;

(together, the Voluntary Escrowed Shares),

- 2,334,620 fully paid ordinary shares will be released from mandatory escrow on 13 December 2023; and
- 15,166,671 fully paid ordinary shares will be released from mandatory escrow on 14 December 2023,

(together, the Mandatory Escrowed Shares).

The Voluntary Escrowed Shares represent approximately 2.85% of all shares on issue.

The Mandatory Escrowed Shares represent approximately 6.60% of all shares on issue. The Company will apply for quotation and lodge an Appendix 2A for the Mandatory Escrowed Shares upon their release from escrow in accordance with the ASX Listing Rules.
