CORRECTION OF AGM VOTE

It has come to the attention of BetMakers Technology Group Ltd (ASX:BET) (**BetMakers** or the **Company**) that, at the Annual General Meeting held on 30 November 2023 (**AGM**), shares held by a custodian were incorrectly recorded as voting in favour of Resolution 1 (Approval of Remuneration Report) when those shares should have been recorded as abstaining on that resolution.

After adjusting for these votes, 72.58% of the votes cast were in favour of Resolution 1. As more than 25% of the votes were cast against Resolution 1, this constitutes a 'first strike' for the purposes of section 250U of the Corporations Act 2001 (Cth).

Updated details of the adjusted voting results and proxies in respect of the resolutions are set out in the attached summary.
