## **UPDATE ON POTENTIAL CONTROL TRANSACTION WITH IDEAGEN**

Damstra Holdings Limited (ASX: DTC) (**Damstra** or the **Company**) refers to previous announcements regarding its ongoing discussions with Ideagen Limited (**Ideagen**) in relation to a conditional, non-binding, indicative proposal to acquire 100% of Damstra's shares for \$0.27 cash per Damstra share by way of a scheme of arrangement under Part 5.1 of the *Corporations Act 2001* (Cth) (**Proposal**).

Ideagen has reconfirmed the Proposal to Damstra on a regular basis, including on 21 December 2023, and is continuing to progress its due diligence investigations whilst working cooperatively with Damstra towards entry into a scheme implementation deed. Damstra and Ideagen have therefore agreed to extend Ideagen's exclusivity to 25 January 2024 (**Further Exclusivity Period**) in accordance with the terms of the exclusivity deed released on ASX on 23 November 2023. For the avoidance of doubt, the no talk and no due diligence provisions of the exclusivity deed will be subject to a fiduciary carve out during the Further Exclusivity Period.

The Proposal is non-binding and highly conditional. There is no certainty that any binding transaction will proceed or eventuate as a result of the Proposal.

Damstra reiterates that no action is required by shareholders at this time. Damstra will continue to keep the market informed in accordance with its continuous disclosure obligations.
