Q2 FY24 Quarterly Report and Appendix 4C

Damstra Holdings Limited (ASX:DTC) (**Damstra** or the **Company**) today reports its second quarter trading update for the quarter ending 31 December 2023 (**Q2 FY24**).

Highlights

- Operating cash flow \$1.7m, vs pcp of \$1.9m
- Free cash flow¹ (\$0.5m), vs pcp negative (\$1.2m)
- Gross Profit of \$5.5m, vs pcp of \$5.3m
- 7th consecutive quarter of positive operating cash flow
- EBITDA² of \$1.7m, vs pcp of \$1.4m
- Cash on Hand at 31 December of \$6.24m
- Damstra enters into a Scheme Implementation Deed with Ideagen

Commenting on the financial results for Q2 FY24, Chief Executive Officer, Christian Damstra, said:

"Our Q2 results demonstrate the continuing improvement in our business after the major transformational activity we undertook in FY23. Further confidence in our business is underpinned by new contract wins where we are finalising commercial arrangements. We also continue to improve our Enterprise Protection Platform (EPP) and close down legacy systems".

Financial Highlights

Cashflow

Damstra continues its rebound in cash flow generation. Free cash flow for the quarter was (\$0.5m), a \$0.7m improvement on a pcp basis. A small number of client's normal renewal payments were received in early January. If these payments were received on time, free cash flow would have been breakeven for the quarter, and operating cashflow would have exceeded Q2 FY23.

Operating cash flow for Q2 FY24 was \$1.7m, this was down slightly by \$0.2m on Q2 FY23, where operating cashflow was \$1.9m. We have now achieved 7 consecutive quarters of positive operating cash flow.

Profitability

The Company is now generating ongoing profitability, with EBITDA of \$1.7m, \$0.3m higher than \$1.4m in Q2 FY23. EBITDA margin was 23%, up 4 pp on Q2 FY23. The increase in EBITDA reflects the continuing operating leverage within the business.

Gross Profit was \$5.5m, with Gross Margin improving by 4 pp YoY to 75% (Q2 FY23: 71%).

Costs

During FY23, our cost reduction program delivered ~\$9m of annualised savings, and in FY24, we implemented further cost optimisations. The additional \$3m annualised cost savings target has now been implemented.

Total costs as % of revenue for Q2 FY24 was 91%. Compared to a Q2 FY23 of 103%, which is a 12 pp improvement. For context, the FY23 profile was 98% of revenue.

Cash Reserves

Cash on Hand at 31 December of \$6.24m, prior quarter Q1 FY24 \$6.84m

¹ Free cash flow is defined as cash flows from operating activities less cash flows used for investing and financing activities, excluding cash used for acquisitions, repayment of debt and non-recurring restructuring costs.

² Pro forma EBITDA refers to Earnings Before Interest, Tax, Depreciation and Amortisation ('EBITDA') adjusted for non-cash share-based payments, acquisition costs, other non-recurring restructuring costs and impairment expenses.

Client Highlights

The business is focused on implementing and configuring recent client wins including clients who are upgrading to the EPP as well as new client acquisitions. These projects include clients in the mining segment, including the Barrick Africa rollout and the implementation of ANZ mining clients such as Coronado and Newhope.

On 15 December 2023, the Victoria Government announced contract signings for the North East Link Projects, Victoria's largest ever road project, with contracts to deliver the Eastern Freeway Upgrade and M80 Ring Road Upgrade. Damstra will be providing services to the two successful consortiums Nexus and AMA.

Our pipeline of near-complete contract wins and renewals remain robust and includes:

- We are in final contract negotiations with Idemitsu Australia, covering all their operations in Australia, after being advised we were successful in their tender process. Once the contract is finalised, we will move to immediate implementation.
- A contract extension with one of our larger clients, Holcim Australia, is being finalised with an expected 10%+ contract value increase.
- John Holland Group's tender process is complete, and we have been advised we are the successful tenderer. We already have operating locations with this client in one of their divisions and are targeting companywide implementation in 2nd half of FY24.
- Have been shortlisted as a tenderer with the Clean Energy Council.

Damstra enters a Scheme Implementation Deed with Ideagen

Damstra announced on the 25th January 2024² that it had entered into a binding Scheme Implementation Deed (SID) with Ideagen Limited (Ideagen), which provides for the acquisition by Ideagen of 100% of the shares in Damstra by way of a Scheme of Arrangement under Part 5.1 of the *Corporations Act 2001* (Cth) (Scheme) for \$0.24 cash per Damstra share.

- Damstra has entered into a Scheme Implementation Deed with Ideagen, under which Ideagen will acquire 100% of the shares in Damstra by way of a Scheme of Arrangement.
- Under the Scheme, Damstra shareholders will receive \$0.24 cash per share³, which represents a 140% premium to Damstra's undisturbed share price on 24th October 2023 of \$0.10 per share.⁴
- The Damstra Board (including the independent board committee formed for the purpose of considering
 the Scheme) unanimously recommends that Damstra shareholders vote in favour of the Scheme in the
 absence of a superior proposal and subject to the independent expert concluding that the Scheme is in
 the best interests of Damstra shareholders.
- The Directors of Damstra, who in aggregate hold or control approximately 19.7% of Damstra's shares as at the date of this announcement, intend to vote, or cause to be voted, all Damstra shares held or controlled by them in favour of the Scheme.
- Significant shareholders associated with Mr Johannes Risseeuw and Mr Christian Damstra controlling over 15.3% of Damstra's shares have agreed to grant Ideagen call options to acquire in aggregate a total of 15.3% of the issued Damstra shares.
- The transaction is subject to Foreign Investment Review Board approval, and other customary conditions, including Damstra shareholder and Court approval.

Payments to related parties of the entity and their associates

Included in section 6.1 of the Appendix 4C for the quarter ended 31 December 2023, payments of \$274,349 were made to related parties of Damstra. These amounts relate to Directors' fees, salaries, and allowances paid to Directors and their associates.
