

MARKET UPDATE FOR QUARTER ENDED 31 DECEMBER 2023

BauMart Holdings Limited (ASX: BMH) ("BauMart" or the "Company") provides the following operational update along with the Appendix 4C for the quarter ended 31 December 2023.

Group Operations and Commentary on Appendix 4C

- The quarter was largely focussed on generating cashflow from the mining consumables business and in this regard, the Company received inflows of \$364K.
- During the quarter, the Company fully settled the outstanding trade facility and premium funding account amounting to \$261K.
- Subsequent to the repayment, the Company has made no further draw downs and continues to have access to a combined \$300K trade financing and overdraft facilities.

Source & Procure Division

- The Company continued to develop improved supplier relationships for this division.
- The Company is monitoring recent upheavals in seaborne freighting channels and its implications on the operations of this division.
- One of its key customers for mining equipment and consumables is currently negotiating development financing for its mining project in West Africa and the Company continued to work with this client to develop further business.

Washpod Division

• During the quarter, the Company continued the investigation and negotiation with strategic partners in relation to the development of new overseas markets for its Washpod products.

Related Party Payments and Other Overheads

- Payments to Related Parties totalled \$3K for the quarter, comprised of directors' fees and salaries.
- Other operating overheads during the quarter were largely in line with management expectations.
- The Company continues to conserve overhead costs to enable the Company to better fund future orders of mining equipment and costs associated with the assessment and development of new business and investment activities.



Other Activities

 The Company continued the review of new investment opportunities to broaden and diversify its existing business operations. Along with this investment outlook, the Company is also considering appropriate funding strategies to support additional business activities that will add shareholder value.
