MELBOURNE, AUSTRALIA (31 January 2024): Hexima Limited (ASX:HXL) (**Hexima** or **Company**) today releases its Appendix 4C and sets out below its quarterly activities report for the quarter ended 31 December 2023.

During the quarter, Hexima continued to explore opportunities for transactions with third parties which could enhance or enable the potential value of the Company's assets, including its intellectual property and other intangible assets, to be realised. The Board continues to advance this goal of maximising shareholder value through a transaction.

Financial update

The company closed the quarter with \$1.91m in the bank and is expecting to receive an R&D Tax Incentive refund of over \$600k in the January – March 2024 quarter.

Net cash used in Operating activities for the quarter was \$95k, which largely comprised ongoing compliance costs and professional fees.
