Answer: No. With the continuing wet season impacting opportunities to explore the north-Queensland tenements, any spending on existing tenements will be minimal and office-based analysis. Overheads have also been reviewed and reduced.

8.8.2 Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: The business is currently being funded from Director loans from the Managing Director and is seeking more sustainable funding in the near term. Details of a capital raising (potentially placement followed by a rights issue) will be released shortly once finalised.
