NOTICE OF HEARING TO APPROVE THE PROPOSED SCHEME OF ARRANGEMENT

Damstra Holdings Limited (ASX:DTC) (**Damstra**) refers to the proposed scheme of arrangement between Damstra and its shareholders (**Scheme**) and the explanatory statement and notice of meeting in relation to the Scheme released to the ASX on 11 March 2024 (**Scheme Booklet**).

Subject to Damstra shareholders approving the Scheme by the requisite majorities at the Scheme Meeting, to be held on Wednesday, 10 April 2024, the Court hearing to approve the Scheme (**Second Court Hearing**) will take place at 9:15am (Sydney time) on Tuesday, 16 April 2024 at the Supreme Court of New South Wales at Law Courts Building, 184 Phillip Street, Queens Square, Sydney NSW 2000, Australia.

Damstra shareholders have the right to appear and be heard at the Second Court Hearing to oppose the approval of the Scheme. If you wish to oppose the approval of the Scheme at the Second Court Hearing, you must file with the Court, and serve on Damstra, a notice of appearance, in the prescribed form, together with any affidavit on which you wish to rely at the Second Court Hearing. The notice of appearance and affidavit must be served on Damstra at its address for service at least one day before the date fixed for the Second Court Hearing.
