## BOARD CHANGES

**10 April 2024, RocketDNA Ltd (ASX: RKT)**, a global drones-as-a-service provider, advises of the appointment of David Morton to the Chairman role of RocketDNA Ltd. Chris Clark has transitioned from the role of Chair to focus on his role as Managing Director and CEO.

David Morton joined our Board as a Non-Executive Director in March 2023. Since this time, he has provided strong input into the Company across a range of areas including: formalising the business model, raising funds and driving the enterprise sales strategy.

Much has been achieved in the last 12 months and as a Company we are excited by the times ahead and its growth prospects. I look forward to continue working with Chris and his team. I am fully aligned with the Company's success as demonstrated by buying shares on market during the past 12 months and in participating in our recent share placement to fund the autonomous drone solution (xBot®)."

**RocketDNA CEO Christopher Clark said:** "David has been an invaluable addition to the Board, providing support and guidance not only from a strategic and corporate governance perspective, but has also demonstrated his long-term commitment via the recent raising.
