# RINCON LITHIUM PROJECT – PROGRESS UPDATE

## **HIGHLIGHTS**

 2,000tpa operational works have achieved continuous operations on the path toward increasing effective production

Argosy Minerals Limited (ASX: **AGY**) ("**Argosy**" or "**Company**") is pleased to advise that it has continued progressing operational works at the 2,000tpa lithium carbonate facility, where these remedying works have improved the critical path process to achieve a sustained period of continuous plant operations from 27 April 2024, at our Rincon Lithium Project.

These critical path works involved tythe primary solids filtration circuit - where filter cloths were replaced, modifying the re-pulping station to improve reliability in the secondary stage of solids filtration to increase lithium recovery and process efficiency - by optimising flowline routing, increasing tank capacity and process improvements to expedite the re-pulping cycle time, and ensuring the cooling station can effectively reduce the concentrated brine temperature for primary waste solids precipitation.

Over the 17 day period (to 13 May 2024), which included non-production downtime of  $\sim$ 3 days equivalent to install parts/equipment for additional improvement measures and cleaning of tanks and reactors, the plant produced  $\sim$ 9.7t of battery quality lithium carbonate product during that time.

The Company will keep progressing the critical path works, with a key focus on reducing the re-pulping cycle time (to allow more efficient time for filtration works to increase lithium recovery), to maintain and improve continuous operations, and work toward increasing effective production rates over a gradual build up period.

The Company has further advanced potential product sales arrangements, following product testing works that achieved very positive product quality test results. The Company is determining its ideal sales/off-take strategy and timing for current product sales.

Argosy Managing Director, Jerko Zuvela said "The Company has progressed to a key milestone with the 2,000tpa lithium carbonate plant and we are looking forward to increasing our production operations. There's no doubt we have learned valuable lessons and gone through challenging circumstances, however this provides us priceless experience and knowledge that very few others have within such complex chemical processing facilities, as we progress to fully develop our Rincon Lithium Project."
