**REQUEST FOR TRADING HALT – SIERRA RUTILE HOLDINGS LIMITED (ASX CODE: SRX) – LISTING RULE 17.1**

Sierra Rutile Holdings Limited (ASX Code: SRX) (**Sierra Rutile**) requests that a trading halt (**Trading Halt**) be applied to its ordinary shares in accordance with ASX Listing Rule 17.1, from the commencement of trading on 19 July 2024.

In accordance with ASX Listing Rule 17.1, Sierra Rutile provides the following information in support of its request:

- (a) The Trading Halt is necessary pending the release of an announcement regarding the status of the competing takeover offers for Sierra Rutile.
- (b) Sierra Rutile requests that the Trading Halt continue until the earlier of:
  - (1) such time as Sierra Rutile releases an announcement to ASX in relation to the status of the competing takeover offers for Sierra Rutile; and
  - (2) the commencement of trading on 23 July 2024.
- (c) Sierra Rutile expects that the Trading Halt will be ended by Sierra Rutile releasing an announcement to ASX in relation to the status of the competing takeover offers for Sierra Rutile.
- (d) Sierra Rutile is not aware of any reason why the Trading Halt should not be granted, nor is it aware of any other information available at this stage that is necessary to inform the market about the trading halt.
