	Answer: The entity expects to have higher operating cash outflows as project activities at Myoff Creek (Canada) and Mkuju (Tanzania) are expected to proceed during the September Quarter.

Answer: Yes, the entity has just completed a further \$150k placement and announced its intention to shortly proceed with a rights issue entitlement offer to existing shareholders. Empire Capital Partners Pty Ltd has been appointed Lead Manager in respect of any shortfall that may arise from the rights issue.

Answer: Yes, based on the entity's ability to successfully complete the proposed rights issue to existing shareholders.
