NOTICE OF AMENDED APPENDIX 3Y'S

Attached are the ASX Appendix 3Y's concerning changes to director interests following the completion of the placement approved by Shareholders on 11 September 2024 (**Notices**). Rubicon notes that the Appendix 3Y's for the Executive Directors, Bruce Rodgerson and David Aughton also contain information concerning the Company's Long Term Incentive plan that has not been lodged within the required timeframe of ASX Listing Rule 3.19B.

The Executive Directors were awarded Performance Rights following shareholder approval at the 2023 AGM which were issued on 1 December 2023. In addition, previously held Performance Rights vested into ordinary shares on 4 September 2024. Neither of these changes were advised to ASX within the required timeframe due to oversight.

Rubicon includes in the agenda for each Board meeting a standing item on disclosure of any trading in securities by directors, and the issue of securities was known to Rubicon and the market given shareholder approval had been obtained to issue them. Further, Rubicon is in the process of appointing Oliver Carton as co-company secretary. Oliver is a lawyer with over 35 years' experience and is company secretary of a number of listed, unlisted and not for profit entities. Previously he was a director of KPMG and a Senior Legal Officer for ASIC.

Rubicon considers the arrangements it has in place are adequate to meet its obligations under Listing Rule 3.19B.
