- the FY24 R&D tax incentive rebate of \$4.56 million
- return of a security deposit of \$934,112 subsequent to termination of the Company's former lease over the Frenchs Forest facility.
- Proceeds of \$625,000 from the previous sale of Mannitol business from purchaser Arna Pharma. The Company is pursuing a further approximate \$3.9 million that is still owed by the purchaser.
