<p>Answer: Yes, however since 30 September 2024 the company has received:</p> <ul style="list-style-type: none"> • the FY24 R&D tax incentive rebate of \$4.56 million • return of a security deposit of \$934,112 subsequent to termination of the Company's former lease over the Frenchs Forest facility. • Proceeds of \$625,000 from the previous sale of Mannitol business from purchaser Arna Pharma. The Company is pursuing a further approximate \$3.9 million that is still owed by the purchaser.
