QUARTERLY ACTIVITIES REPORT

Quarter ended 30 September 2024

MELBOURNE, AUSTRALIA (30 October 2024): Hexima Limited (ASX:HXL) (**Hexima** or **Company**) today releases its Appendix 4C and sets out below its quarterly activities report for the quarter ended 30 September 2024.

During the quarter, Hexima continued to work on the proposed acquisition of 100% of the issued capital of Real Thing Entertainment Pty Ltd, which has been the subject of recent announcements.

Financial update

The company closed the quarter with a total cash balance of just under \$2m.

During the quarter \$227k net cash was used in operating activities, comprising interest received of \$8k, and net operating expenditures of \$235k, which largely comprised ongoing compliance costs and professional fees and other costs associated with the proposed acquisition outlined above.

In accordance with Listing Rule 4.7C disclosure requirements, payments made to related parties and their associates included in item 6.1 of the Appendix 4C represented payments for directors' fees and remuneration in the normal course of business at commercial rates, excluding reimbursements for out-of-pocket expenses.
