Answer: Yes, given the Company is an exploration company and not generating any revenue, it is expected that it will continue to have negative operating cash flows for the time being.

Answer: The Board monitors the funding requirements of the Company on an ongoing basis. The Company has been able demonstrate a record of securing funds when required, as evidenced by the raising of ~\$6.1 million during the quarter with the potential for further funding up to \$9.0 million via the issue of convertible notes, and is confident that it will continue to do so.
