Atrum Coal signs Term Sheet for Sale of the Groundhog and Panorama Projects

Atrum Coal Limited (ASX: ATU) (**Atrum** or the **Company**) is pleased to announce that the Company has entered into a binding term sheet with Panorama Resources Pty Ltd (ACN 679 251 999) (**Panorama Resources**), for the sale of the Canadian subsidiaries Atrum Coal Groundhog Inc (**ACGI**) and Atrum Coal Panorama Inc (**ACPI**).

ACGI holds a 100% interest in the Groundhog Anthracite Coal Project with 19 exploration licenses (see Appendix 1), one license under application and a reclamation bond valued at CA\$628,000. ACPI holds 65% interest in the Panorama Anthracite Coal Project with Japan Oil, Gas and Metals National Corporation (JOGMEC), twelve exploration licenses (see appendix 1) and a reclamation bond valued at CA\$55,000.

Panorama Resources is a special purpose corporate entity associated with Perk Capital Advisors Pty Ltd, a Perth based consulting firm focused on restructuring, turnaround and special situations in the Asia Pacific region. The directors of Panorama Resources include Mark Chadwick, a seasoned restructuring professional who has undertaken numerous transactions in the Indonesian coal sector, and Evan Ball who has held senior executive roles in the coal industry with Rio Tinto Coal Australia and PT Bumi Resources Tbk.

The sale is subject to a number of conditions precedent including due diligence, receipt of necessary regulatory approvals and execution of definitive documentation. Atrum has granted exclusivity to Panorama in relation to ACGI and ACPI and their businesses, assets and undertakings. The exclusivity period will end on the earliest of the execution of definitive documents and 31 December 2024 (unless extended).

Under the agreed terms, Atrum will receive an initial consideration of AU\$100,000 on completion. On the 12-month, 24-month and 36-month anniversary of completion Atrum will receive a further AU\$50,000 (**Anniversary Consideration**). The Anniversary Consideration may be reduced if a shortfall is determined in the value of the reclamation bonds between the completion date and the relevant anniversary date.

In addition, Panorama Resources has agreed to pay a permitting consideration of AU\$750,000 upon the successful achievement of all necessary permits and regulatory approvals required for the development and operation of a mine at either project held by ACGI or ACPI, irrespective of whether the mine is developed by ACGI or ACPI. Panorama Resources has also agreed to pay a production consideration of AU\$750,000, which is subject to commercial production and the sale of 250,000 tonnes of commercial product.

Atrum is targeting execution of the definitive sale documentation by 15 November 2024 and completion by the end of November 2024.

Glen Koropchuk, the Chair of Atrum commented "The sale of the Groundhog and Panorama project assets allows Atrum to focus on delivering a favorable outcome for Shareholders in the Elan Coal Limited claim against the Government of Alberta. The claim is for de facto expropriating Elan's coal leases and Atrum is also seeking monetary compensation pursuant to the doctrines of private nuisance and unjust enrichment."
