REQUEST FOR TRADING HALT

Ronin Resources Limited (ASX: **RON**) (the **Company**) requests a trading halt in relation to the Company's ordinary shares ('RON') quoted on the Australian Securities Exchange (**ASX**) in accordance with ASX Listing Rule 17.1.

The trading halt is requested pending an announcement by the Company to the market in relation to a capital raising ('Purpose').
