Smart Parking enters Debt Facility Agreement

Smart Parking Limited (ASX:SPZ) is pleased to advise that it has executed the following debt facilities with HSBC Australia:

- 1) A \$10m AUD multicurrency revolving credit facility made available for general corporate purposes and certain permitted acquisitions for a 3 year term.
- 2) A \$10m AUD multicurrency accordion facility made available for general corporate purposes and certain permitted acquisitions which will be available upon request and satisfaction of certain conditions.
- 3) Other on demand facilities including Letter of Credit facility and a credit card facility.

Interest on the facilities is variable. The facilities are secured by way of all asset security granted by Smart Parking Limited and some of its subsidiaries (who have also guaranteed the facility).

The covenants include a Net Leverage Ratio, an Interest Cover Ratio and a Minimum Tangible Net Worth requirement.

Other terms are customary for facilities of this nature.

SPZ Managing Director, Paul Gillespie commented; *“We are delighted to successfully implement the HSBC facilities. The new facilities mean SPZ has cash reserves and debt capacity to take advantage of opportunities as they arise. We are looking forward to working with HSBC to continue the SPZ growth journey”.*
