

## Oneview Healthcare Security Purchase Plan – Closing Date Reminder

**Melbourne, Australia** – Wednesday, 4 December 2024. Oneview Healthcare PLC (ASX:ONE) (**Oneview**) reminds Eligible Securityholders that the opportunity to participate in the security purchase plan (**SPP** or **SPP Offer**) announced to the market on Wednesday, 13 November 2024 closes **at 5.00pm (Sydney, Australia time) on Monday, 9 December 2024**. The SPP allows Eligible Securityholders to subscribe for up to A\$30,000 of new CHES depository interests over fully paid ordinary shares of Oneview (**CDIs**) without incurring brokerage, commission or other transaction costs.

The SPP follows Oneview's institutional placement announced on Wednesday, 13 November 2024, which raised approximately A\$20 million in gross proceeds (**Placement**).

The issue price per New CDI under the SPP will be A\$0.29, being the same price paid by investors under the Placement and represents a:

- 9.38% discount to the closing price of A\$0.320 on Friday, 8 November 2024; and
- 8.03% discount to the volume weighted average trading price for the 5 business days at the close of trading on Friday, 8 November 2024 of A\$0.315.

Friday, 8 November 2024 being the last day of trading in CDIs before the Placement and SPP Offer were announced.

### Use of proceeds of the Placement and SPP

Oneview intends to apply the net proceeds of the capital raising to strengthen the balance sheet as deployment of the direct pipeline of contracted beds continues and as sales execution in the United States and Canada under the recently extended and expanded Baxter partnership ramps up. The proceeds will also fund Oneview's critical growth initiatives related to its AI strategy and internal configuration tooling to enable more efficient deployment at scale.
