**TO BE RELEASED FOR EACH OF THE ASX CODES LISTED BELOW**

**Notice of closure of Betashares Martin Currie Emerging Markets Fund (managed fund) (ASX: EMMG), Betashares Martin Currie Equity Income Fund (managed fund) (ASX: EINC) and Betashares Martin Currie Real Income Fund (managed fund) (ASX: RINC)**

Betashares Capital Limited (**Betashares**), the responsible entity, gives notice of the upcoming closure of the Betashares Martin Currie suite of funds, namely:

- Betashares Martin Currie Emerging Markets Fund (managed fund) (ASX: EMMG) (“**EMMG**”)
- Betashares Martin Currie Equity Income Fund (managed fund) (ASX: EINC) (“**EINC**”) (“**EINC**”)
- Betashares Martin Currie Real Income Fund (managed fund) (ASX: RINC) (“**RINC**”) (“**RINC**”)

(each a “**Fund**” and collectively “**the Funds**”).

Betashares has applied to the ASX for the trading status of each Fund to be revoked and the ASX has approved this application.

The last day each Fund will trade on the ASX will be:

- EMMG: 22 January 2025
- EINC: 22 January 2025
- RINC: 4 February 2025.

At the end of each Fund’s last trading day, the closure process for that Fund will commence.

**Why are the Funds being delisted and closed?**

The decision to close the Betashares Martin Currie suite of funds recognises that they have not achieved sufficient size since inception, and are not likely to do so.

**Options for investors**

Investors in each Fund have two options:

1. Sell their units on the ASX before close of trading on the relevant Fund’s Last Trading Day (set out above and in the indicative timetable below) via their broker or investing platform in the normal manner; or
2. Continue to hold their units, participate in the relevant Fund’s winding up, and receive a final distribution payment that represents a final distribution of any income (if applicable), as well as their proportionate share of the net proceeds from the sale of the assets of the Fund. This payment will be made to each investor’s nominated bank account for distributions. It is important to note that investors who hold their units and participate in the Fund’s winding up will be subject to market movements until the Fund’s assets have been sold (refer to the indicative timetable for further details).

Investors may obtain exposure to similar investment strategies through Franklin Templeton’s own suite of funds. Given the closure timing of EINC and RINC, these funds will not make a quarterly distribution for the distribution period ending December 2024. Any distributable income will be included as a component of

the final distribution amount payable to each unitholder in the relevant fund as at the Record Date (outlined in the indicative timetable below).

### Fund closure process

Each Fund's constitution permits Betashares to determine the date of termination of the Fund in a notice given to investors. Each Fund will then be wound up in accordance with the provisions of the constitution and the Corporations Act.

This means that the assets of each Fund will be sold and the net proceeds, after deduction of actual or anticipated expenses, will be distributed to investors in proportion to their unitholdings as at the Record Date.

Betashares will bear the expenses associated with winding up each Fund, other than any transaction costs and taxes associated with sale of each Fund's assets.
