## **Appointment of Administrators**

On 2 January 2025 the Directors of the Company appointed Clifford Rocke and Jimmy Trpcevski ("**Administrators"**) of WA Insolvency Solutions as Joint and Several Voluntary Administrators of the Company pursuant to section 436A of the Corporations Act.

The Company's wholly owned subsidiary HiPura Pty Ltd (HiPura) was also placed into Voluntary Admistration with the Administrators being appointed Voluntary Administrators pursuant to section 436A of the Corporations Act.

### Suspension of shares from trading whilst the Company is in Administration

Whilst the Company is in administration, all listed securities will remain suspended. Shareholders are also unable to transfer their shares during this time.

#### **Current status of the Company**

The Administrators are assessing the financial position of the Company and HiPura to determine a strategy that maximises the return to all stakeholders.

The Administrators intend to call for urgent expressions of interest to recapitalise the Company and HiPura through a Deed of Company Arrangement and/or the outright purchase of the assets of the Company and HiPura.
