In parallel with the repayment of the Upwell Facility, the Company entered into a new revolving credit facility for up to US \$15.0 million (the "Revolving Facility") on more favourable terms for the Company than the Upwell Facility. On October 31, 2024, the Revolving Facility was expanded from \$15.0 million to \$20.0 million.</p>
