

# GLOBAL HEALTH'S MASTERCARE SECURES \$1 MILLION CONTRACT WITH YOUTURN

Expanding digital healthcare solutions for youth mental health services

### **Investment highlights**

- The \$1 million contract over three years with Youturn will enhance service delivery across Youturn services.
- It will see the Implementation of MasterCare+ for case management and clinical tracking, the HotHealth Digital Front Door platform to improve client engagement and accessibility and ReferralNet Secure Messaging platform to securely share sensitive patient and clinical data across care teams.
- The partnership will be deployed to over 200 users across an initial 12 healthcare service organisations nationwide.

The \$1 million agreement over 3 years includes two 3-year extensions and provides for data conversion from existing systems where appropriate, and the deployment of the Global Health's SaaS portfolio centered on the Company's MasterCare+ Case Management and shared Electronic Medical Record for Multi-Disciplinary Care Teams.

#### Strengthening digital healthcare capabilities for Youturn

Strengthening digital healthcare capabilities for Youturn, Global Health will implement its suite of digital health SaaS solutions to optimise Youturn's operations, improving workflow standardization, service efficiency and accessibility. The deployment will feature <a href="MasterCare+">MasterCare+</a>, which streamlines case management and service delivery, integrated with MasterCare's HotHealth digital front door for online engagement between services, clinicians and clients, and <a href="ReferralNet">ReferralNet</a>, which provides secure sharing of clinical documents across multiple providers. The goal of the project is to improve efficiency and support better service delivery for Youturn.

### **Rollout across key Youturn locations**

The implementation will take place across Youturn's key services, including the Youth Enhanced Service (YES) in Darling Downs and Adelaide, eight headspace centres, including in Maroochydore and Toowoomba, as well as StandBy services offering phone counselling, after-hours support, and locations in NSW and NT.

These services will benefit from the enhanced digital solutions to improve their operations and service delivery, particularly in regional areas.

Global Health Managing Director Mathew Cherian said: "This partnership underscores our commitment to driving workflow productivity across health services through our portfolio of integrated SaaS platforms, enabling clinicians to spend more time with people living with vulnerable mental health challenges."
