

## UPDATE ON RESULTS OF SCHEME MEETING

Melbourne, 26 June 2025

### Update on Results of Scheme Meeting

PointsBet Holdings Limited (**PointsBet**) refers to its ASX announcements regarding the outcome of the results of the Scheme Meeting held yesterday in relation to the proposed acquisition of PointsBet by MIXI, Inc (**MIXI**) through its wholly owned subsidiary MIXI Australia Pty Ltd (**MIXI Australia**) by way of a scheme of arrangement.

Computershare were engaged to conduct all aspects of the Scheme Meeting, including all proxy voting. PointsBet was informed yesterday evening at around 8:40 pm (Melbourne time) by Computershare, that due to a system error on its part, the proxy lodged by Betr Entertainment Limited (**Betr**) proxy was not revoked as previously advised by Computershare to PointsBet. Consequently, Betr's votes were incorrectly excluded by Computershare from the final voting results that were provided to PointsBet at the conclusion of the Scheme Meeting.

A letter from Computershare explaining the circumstances surrounding the system error and attaching an amended voting report for the Scheme Meeting is **attached** to this announcement. PointsBet had all times relied on voting results recorded by Computershare, which were confirmed by Computershare in writing prior to the release of PointsBet's announcement informing the market of the outcome of the Scheme Meeting.

As a result, the Scheme Resolution (as set out in the Notice of Meeting at Annexure C of the Scheme Booklet) was not approved by the requisite majorities of PointsBet Shareholders.

I am writing in regard to the Scheme Meeting undertaken by PointsBet today, 25 June 2025.

Computershare Investor Services were engaged by PointsBet, as their registry provider, to conduct all components of the Scheme Meeting, including all proxy voting, and the voting both online and in person during the Scheme Meeting.

I acknowledge that at the conclusion of the Scheme Meeting, the Computershare Returning Officer informed PointsBet and Baker McKenzie that a representative of Betr had attended the meeting online, they had revoked the Betr proxy but not cast a vote at the meeting and that accordingly the shares held by Betr were not voted at the Scheme Meeting. That information was confirmed in writing to Baker McKenzie during the course of the day.

I confirm that this evening we undertook a detailed review of the circumstances behind the exclusion of the proxy votes for BBTR and following the review we determined that, due to an issue with the system set up for the meeting, Betr's votes were incorrectly excluded from the final voting results that we provided to PointsBet at the conclusion of the Scheme Meeting. I confirm that Betr's proxy was not revoked by the Betr representative.

We determined this to be the case at around 8.00pm this evening following which we briefed the Returning Officer and instructed them to call Baker McKenzie. The Returning Officer then spoke with Baker McKenzie at 8.40pm.

Please find attached a letter which sets out amended voting results for the meeting.

We sincerely apologise for this situation and assure you that we appreciate the gravity of this matter and are committed to working with you to resolve it.
