## **Financial Results Update**



- 1. A former provider of company secretarial, tax agency, and financial management services has acted improperly
- 2. iCandy Australian bank accounts were used to receipt and transit fraudulently received funds over a number of years
- 3. Relevant person(s) had no access to subsidiary operational entity bank accounts and no impact on subsidiary operations has been identified
- 4. Subsidiary companies continue to be audited by independent auditors successfully ICI is confident this issue relates solely to the parent entity
- 5. ICI appears to be one of a number of Australian entities to have fallen victim to this conduct by the relevant person(s)
- 6. Identification of this issue has resulted in the Company being unable to finalise its CY2024 financial results and subsequent disclosures

## **Reinstatement - Process / When**



#### Steps Taken

- 1. Exploring all avenues of legal actions including against the relevant person(s), and other relevant professional services providers to the Company
- 2. Engagement of Hamilton Locke as legal advisors to explore all recovery actions and to assist in the quantification of the fraudulent activity
- 3. Hamilton Locke have engaged a forensic accountant to review the Company's historical financial results
- 4. Progressing discussions with the Australian Taxation Office (as the improper conduct includes fraudulent Goods and Services Taxation refund claims)
- 5. Actively cooperating with relevant authorities on their investigations
- 6. Actively working towards a recommencement of trading on ASX towards Q4 CY2025

## **Reinstatement - Process / When**



#### **Next Steps**

- 1. Preparing financial statements for external audit
- 2. Producing quarterly cash flow and activity statements that have been delayed
- 3. Engagement with ASX towards recommencing trading in ICI securities on ASX

ICI is targeting to recommence trading on ASX in Q4 CY2025
