PRIORITY 5 : CASHFLOW POSITIVE FOR FY25

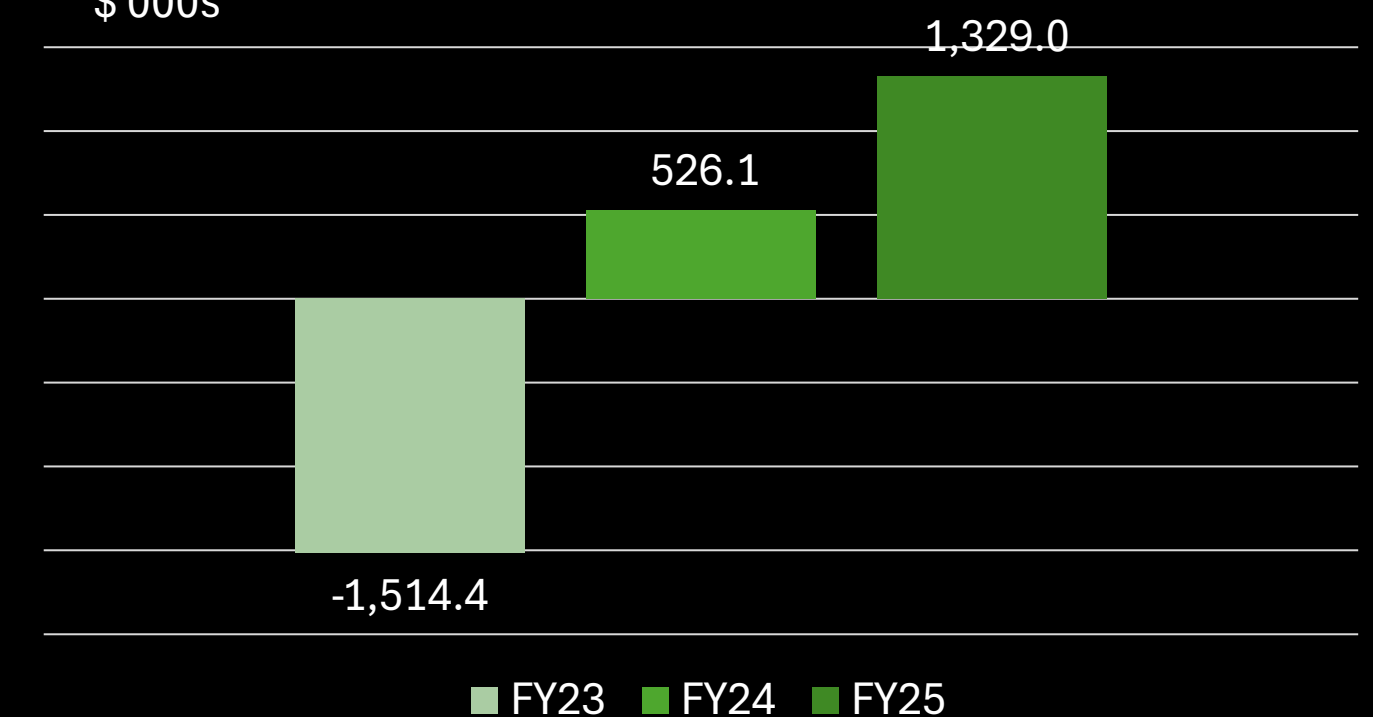


- > Total cash at bank as at 30 June was \$1.53M. With the settlement of the remaining EagleSoft consideration, we are now debt-free and generating positive cash flow.
- > Operating cash inflows of \$1.33M, enhanced by the R&D tax offset, demonstrate a strong cash generation performance for the period. The tax offset provides a one-time boost to cash flow, serving as a key source of liquidity for the business.
- > The company is generating strong cash flow from its core operations, which is essential for maintaining day-to-day operations, funding future growth, and meeting working capital needs.
- > We will continue to prioritise cash flow generation and liquidity management to ensure the long-term success of the business.

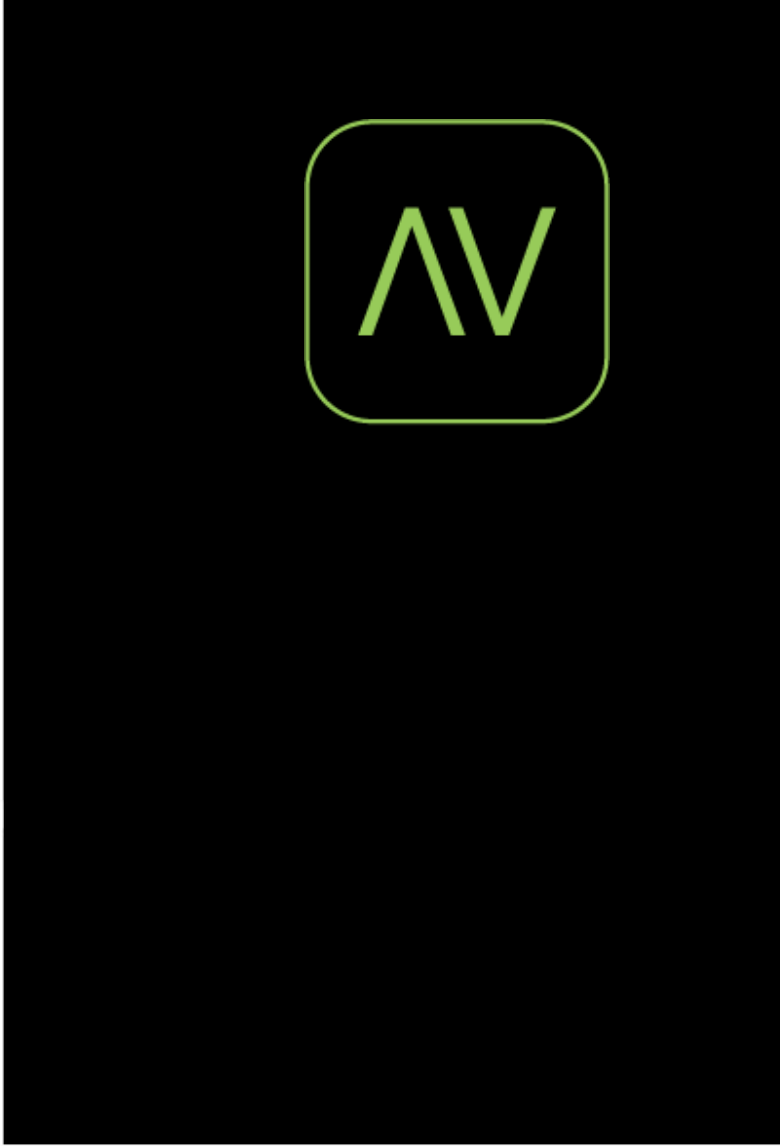
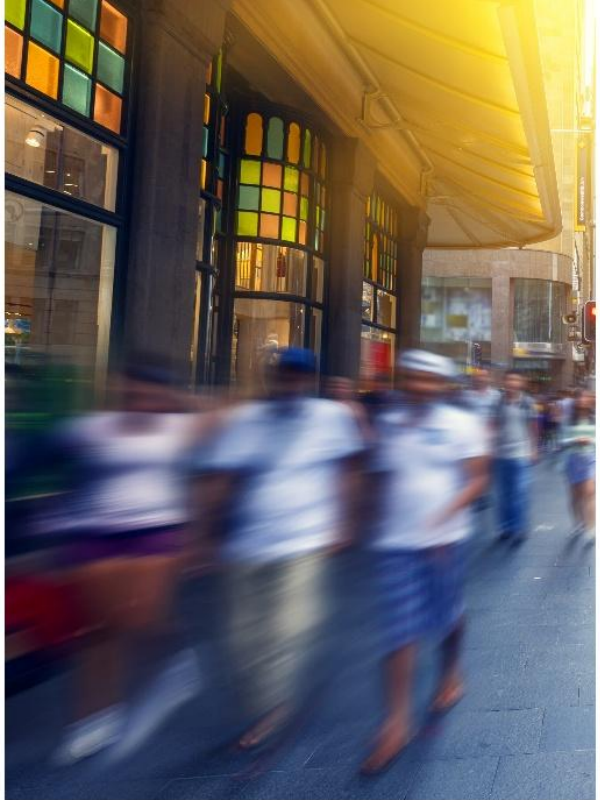
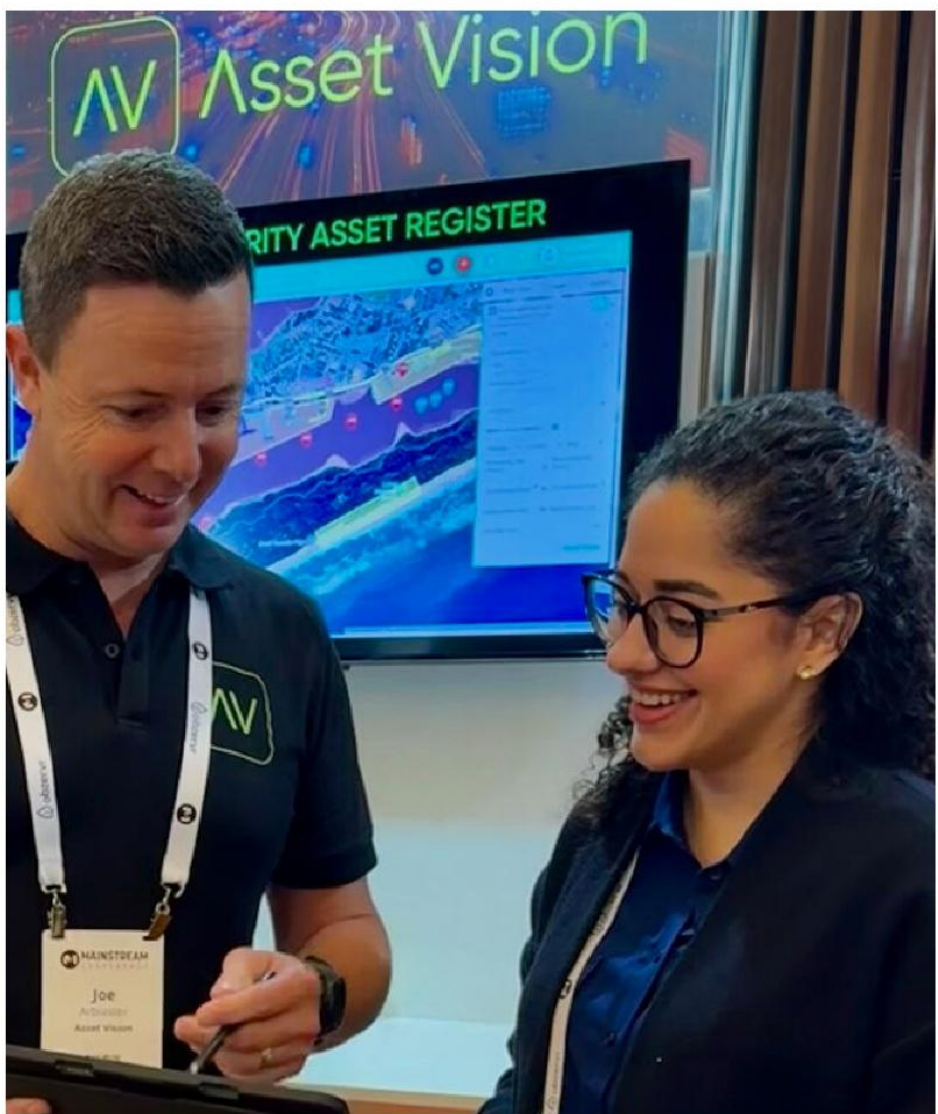
Total Cash and Cash Equivalents

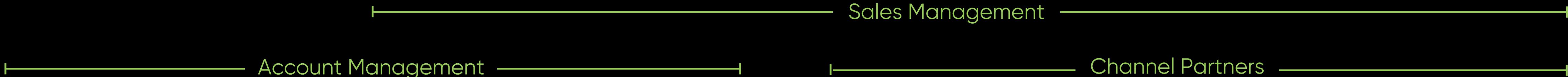
