MANAGING DIRECTOR'S REVIEW

WE RECOGNISE THAT THESE LAST 12 MONTHS HAVE BEEN A CHALLENGING PERIOD FOR ZOOONO SHAREHOLDERS AND FIRSTLY, WANT TO THANK THOSE THAT CONTINUE TO SUPPORT US.

In changing the direction and focus of the Company, moving away from the B2C consumer business to B2B has caused delays in getting the business back into profit, however we do believe the hard work has been done and the next 6-12 months should see a turn round in the Company's financial performance.

We do appreciate the patience of shareholders. It does at times seem to take an extraordinary amount of time to get testing, regulatory, safety, and efficacy testing completed, let alone get contracts signed and most importantly receive orders.

Despite the delays, we are making good progress. Several markets have been re-opened by our distributors, including Korea, Japan, China and India. In Korea, for example, Zoono products have just received KFDA approval and we expect first orders by the end of September.

In India we are focusing on the Agri markets where our products have shown considerable improvements in crop yields. We now have two distributors in place.

In China, we have one distributor focusing in the online and pet markets and are in final stages discussions with several other distributors for different vertical markets including textiles, medical, healthcare and public transport.

As evidenced above, while we remain active in markets like hygiene, healthcare and agriculture, the shelf-life extension technology developed in conjunction with OSY Group continues to be our major focus.

The economics for producers, transporters and distributors (including supermarkets) of extending the shelf-life of fresh produce are compelling. We are executing our strategic plan, all be it more slowly than initially hoped, but that is unfortunately the nature of the new business area into which we are moving.

The last two years have been challenging. However, we are confident of success and are concentrating on what we can control. There are many trials of Zoono products and technologies and negotiations in progress with supermarket chains and leading packaging companies across multiple geographies.

We expect strong news flow from this initiative across the next 12 months, especially as we have now also moved into testing of our products with other fresh food groups. The results of testing to date have been very positive.

OSY PARTNERSHIP

OSY Group are our exclusive partner in the shelf-life extension project and, following on from the successful UK trials, testing of Zoono products is already underway in many countries. We expect to sign 5 to 6 significant supply agreements in the next 12 months.

RIGHTS ISSUE

In June 2025, Zoono undertook a rights issue. A\$785,006 was raised by the rights issue (before issue

costs).

The balance (shortfall) of the rights issue has now been placed to two experienced UK investors who are also investors in OSY.

The total new capital raised by the right issue was circa AUD\$1.8m (before issue costs). All Directors and key staff also took up their full entitlement in the rights issue.

Thank-you to all Zoono shareholders, employees and stakeholders. Your Board is working hard to maximise the potential of the Company's products and to improve returns to shareholders.

While we recognise the volatility of our recent journey, your Board believes the Company is now well positioned to continue to capitalise on its opportunities into the future. We look forward to keeping you informed on progress during the coming year.

DIRECTORS' REPORT

Your Directors present their report on Zoono Group Limited ('Company') and its controlled entities (together called the 'Group' or the 'Consolidated Entity') for the financial year ended 30 June 2025.

All numbers stated in this report are in New Zealand dollars, unless otherwise stated or converted at the exchange rates provided.

PRINCIPAL ACTIVITIES

The principal activities of the consolidated entity during the year were to develop and sell a range of antimicrobial products in multiple countries.

OPERATING RESULT

The Group recorded an after-tax loss of NZ\$3,926,090 (2024: NZ\$9,088,364 loss) for the financial year.

REVIEW OF OPERATIONS

While market conditions continue to remain challenging, the Company expects to see an improvement occurring in its China, Japan, South African, Korean and Indian markets. Further, growth is set to occur in our shelf-life extension technology project where, having secured supply contracts with a major UK supermarket chain and a leading EU based food packaging company, Sharpak Aylesham Limited (**Sharpak**), the Company believes it is well placed to gain additional new supply contracts.

GROWTH OPPORTUNITIES

When, around three years ago, the Company's traditional markets for anti-microbial products were decimated by over-supply problems and dwindling public sentiment, the Board made a bold decision, of necessity, to focus on the pursuit of niche sectors which it believed suited the characteristics of the Company's products and where significant sales opportunities existed. One

such sector, introduced to Zoono by OSY Group Limited (**OSY**), was the food supply chain sector and, in particular, the application of the Company's products to food packaging for the purpose of extending the shelf-life of fresh produce and, at the same time, reducing food waste (which is a major challenge for supermarkets and food producers across the globe).

In conjunction with OSY (Zoono's partner in this project) and following nearly three years of testing and promotion of its shelf-life extension products and technologies, Zoono announced that it and OSY had signed an exclusive agreement with Sharpak. The agreement builds on the Company's platform in the UK & EU food shelf-life extension market, via advanced trials with multiple leading supermarkets and international food producers. One leading UK premium supermarket has endorsed the technology's status as a "game changer" in the industry due to its unique ability to be applied to a wide range of products and packaging types. Sharpak's operations in the UK have a large share of the market for the packaging of soft fruits sold by UK supermarkets, with its packaging also used for a broad cross-section of other fresh produce and food categories, including meat and poultry.

Key terms of the agreement with Sharpak are:

- An exclusive contract for an initial term to 31 December 2029 for the United Kingdom only;
- Zoono products are to be applied on rigid pot, tub and tray packaging for the storage, delivery and/or packaging of strawberries, raspberries, blackberries, blueberries and grapes ("soft fruits").
- Sharpak will have the right of first refusal if another packaging manufacturer wants to use the Zoono products on the packaging for soft fruits in any country in the European Union, Norway or Switzerland;

It is Zoono's expectation that the first product order will be received from Sharpak when the in-store trial processes with UK supermarkets conclude later this calendar year. Thereafter, revenues are anticipated to increase as Sharpak ramps up production in Q2/Q3 FY2026 and begin broader supply into the UK market.

Other potential developments:

Trials are continuing with three other leading UK supermarket chains, international food producers and import/export companies. The trials are also across a range of food categories including grapes, stone fruits, lychees, cherries, fish, meat, ready-made meals and poultry. Results to date have been positive, delivering the customer's targeted minimum shelf-life extension for commercial viability across every fresh produce category tested so far.

Zoono anticipates Sharpak and its related entities will steadily increase implementation of Zoono products and OSY technology into packaging for other food sectors and into further markets in the EU and other geographies.

With trials on-going in other countries, Zoono is optimistic that further large packaging companies will come on board across the globe in FY26.

SOLVING FOOD WASTAGE

The food waste problem:

Globally, it is estimated there is circa US\$2.6 trillion of food waste every year, with nearly 25% of all fresh fruit and vegetables lost worldwide through food waste. It is a major issue for all participants

in the food supply chain, with the enormity of the issue exemplified by the fact that the fresh produce market in the UK alone (which accounts for approximately 40% of grocery sales) is worth approximately NZ\$187B.

Why Zoono is part of the solution:

Extending the shelf-life of fresh produce through the combined use of Zoono's product and OSY's application technologies to the packaging (Solution) provides benefits for all participants in the supply chain. The Solution is compliant with UK & EU Food Contact Material Regulations, including having satisfied the regulatory authorities that the product does not leach from the packaging into the produce.

For the food producers, the benefits are reduced financial losses from wastage (in both transit and pre-store) and improved quality performance of the produce leading to increased sales. The increased shelf-life also increases the potential for export of the produce.

For the packaging manufacturers, because the OSY application technology can be easily integrated into existing packaging production for most forms of packaging (includes lidding film, semi-rigid plastic trays, flow wrap, board and film combined, fibre/board, board and film combined food-to-go, flexible film paper and outer packaging), it provides the packaging manufacturers with the ability to offer their customers benefits through packaging which maintains food quality for longer, hence building immediate brand trust and generating financial benefits from a reduction in food wastage. It also facilitates the expansion of geographical supply and the ability to reach into new markets.

For supermarkets, the benefits are significant. For certain products, an extra one-day extension of shelf-life can reduce food waste by up to 50%, which results in material reduction in financial losses incurred from wastage, reduction in costs of disposal, shelves fuller of fresh produce and increased profit margins.

Lastly, for consumers, the benefits are also very positive - fresher produce in stores and reduced food wastage at home.

Shelf-life extension project - UK, Europe, Asia, Africa, and Australia:

Within the shelf-life extension project, Zoono and OSY are currently conducting 45 trials across four continents and a diverse range of customers (primarily supermarket chains, food producers, packaging companies and exporters).

Where the earlier trials were focused predominantly on soft fruits, the focus has now broadened substantially to include other fruits and vegetables, meat, fish, poultry, bread, ready-meals and fresh flowers. All trials to date have been successful. In addition to the above trials, there are many other companies engaged in discussions with either Zoono and/or OSY in relation to the products and technology. The number of trials and level of inquiry is positive evidence of the potential future longer-term revenue streams available to the Company from this niche market.

The most advanced trials are in the UK with two large UK supermarket chains. The success of those trials led to the signing of the Sharpak agreement. Zoono expects it will start earning revenue from its UK supermarket customers in Q2 / Q3 of FY26.

OUR MARKETS

Zoono is also making progress in its target Asian markets of China, Korea, India and Japan. Orders

were received in Q4 FY25 from a large Japanese pharmaceutical company, for product which will ultimately be used in the textile industry, and repeat orders are also expected from Animal Health for supply into Australia in Q2 FY26.

WORKING CAPITAL

Zoono announced a rights issue in June 2025 which raised A\$785,006 in new funding for the Company (before issue costs). These funds were received after year-end.

Subsequent to year end of the year, the balance (shortfall) of the rights issue has now been placed to two experienced UK investors (who are also investors in OSY).

The total new capital raised by the right issue was circa AUD\$1.8m (before issue costs). All Directors and key staff also took up their full entitlement in the rights issue.

With the success of its cost reduction program, in conjunction with having the benefit of the above new funds, the Company is confident that it has sufficient funding to meet its business objectives over the next 12 to 18 months. The Board is, however, fully aware that the Company's working capital position remains dependent on the future success of its sales and marketing efforts, and cash receipts from customers, over the coming several quarters.

LEGAL

The Company is currently being prosecuted by the New Zealand Commerce Commission for allegedly unsubstantiated representations made about its hand sanitiser and microbe shield surface spray products, contrary to section 12A of the Fair Trading Act 1986. Zoono believes it has complied fully with its legal obligations and intends to strenuously defend the action. In making its public representations concerning the efficacy and durability of its products, Zoono have relied on of over 200 independent tests undertaken by laboratories worldwide in accordance with recognised standards. The Court case has been set down for 4 May 2026.

THE FOCUS

The Company's strategy remains focused on creating long-term sustainable growth which produces consistent, maintainable and growing returns to the shareholders. The key initiatives to support these efforts include:

- prioritisation of opportunities offering the greatest potential for long-term value creation (which, by definition, must include better identifying those market sectors and products where the Company believes it has a material commercial advantage);
- determining how the Company can best leverage its opportunities and tailor its message for the different market segments;
- growing existing key customers and seeking new revenue streams in each of the Company's core markets; and
- supporting the commercialisation efforts of our strategic partners through its shelf-life extension technology.

The Company remains optimistic about the future of long-lasting antimicrobial coating technology.

Zoono believes its technology fundamentally offers a more sustainable and more cost-effective solution than incumbent offerings. The Company will continue to seek to change habits, perceptions and grow market share across its core geographies and markets (facilities management, textiles, livestock, shipping and healthcare), with a particular focus on food packaging.

FINANCIAL PERFORMANCE

In the 12 months to 30 June 2025, the Group increased its revenues by NZ\$200,812 (a 19.1% increase) to NZ\$1,250,133 compared to the previous year. The growth was primarily an increase in textile sales to Japan and Animal Health sales to Australia.

Gross profit achieved was NZ\$457,714 (36.6% of revenue) in the current year compared to NZ\$274,345 (26.1% of revenue) in the previous year. This included the loss of NZ\$199,858 incurred on the sale of the US plastic bottle stock (primarily done to reduce storage charges). If that loss is excluded, the gross profit percentage for the year would have been 52.6%. The uplift in the gross profit was mainly due to an increase in revenues and better margins across the Group.

Operating costs decreased by NZ\$4,923,020 (52.2% decrease) compared to FY24, primarily driven by ongoing restructuring savings of NZ\$631,178 and a reduction in the stock obsolescence provision of NZ\$4,291,842 (FY24: NZ\$5,053,503).

The consolidated Group net loss after tax for the year was NZ\$3,926,090 compared to a loss of NZ\$9,088,364 in the previous year.

CAPITAL MANAGEMENT

Operating cash flow was a net cash outflow of NZ \$1,701,601 in the current year, a decrease of NZ\$1,461,324 over the previous year.

This was predominately due to a combination of higher cash receipts for the year of NZ\$464,035 and lower operating costs due to the restructuring undertaken and, in particular, a reduction in employee costs of NZ\$73,184 and administration expenses of NZ\$456,641.

The Group ended the year with NZ\$51,071 in cash reserves compared to NZ\$1,961,284 in the previous year, a decrease of NZ\$1,910,213.

DIVIDENDS

No dividends were paid, recommended or declared during the financial year.

FINANCIAL REVIEW

Zoono Group Limited continued to make strategic, operational and financial progress during the year, despite a difficult international climate. On a consolidated basis, the Group delivered:

- Revenue: NZ\$1.2m (FY24: NZ\$1.0m)
- EBITDA loss: NZ\$4.205m (FY24: NZ\$8.778m EBITDA loss)

BALANCE SHEET

The Group continues to maintain a good balance sheet position with net assets of NZ\$3.2m compared to the prior period of NZ\$6.8m and no bank debt.

EMPLOYEE OPTIONS

During the year no employee options were issued to Directors or non-director employees.

Option holders do not have any rights to participate in any issue of shares or other interests of the Company or any other entity.

SIGNIFICANT CHANGES IN THE STATE OF AFFAIRS

There were no significant changes in the state of affairs of the Group during the financial year.

MATTERS SUBSEQUENT TO THE END OF THE FINANCIAL YEAR

Following the recent non-renounceable rights issue in June 2025, the Company has been able to place the entire shortfall of 28,349,219 shares at A\$0.035 in August 2025, raising a further A\$992,223 in working capital. It brings the total amount raised under the rights issue up to circa A\$1.78m (before the costs of the issue are paid).

The shortfall placement was made to investors and associates who hold a shareholding in OSY Group Limited (who are driving the shelf-life extension projects along with Zoono Group). This follows on from the placement of 20,000,000 shares made last year to OSY Group Limited and brings its shareholding (together with its associates) to 48,349,219 shares (or 11.9% of the total issued share capital of the Company).

No other matters or circumstances have arisen since the end of the financial year which significantly affected or may significantly affect the operations of the consolidated group, the results of those operations, or the state of affairs of the consolidated group in future financial years.

LIKELY DEVELOPMENTS, PROSPECTS AND BUSINESS STRATEGIES

The consolidated entity will continue its strategy to focus on the progressive expansion of the sale and marketing of its product line.

ENVIRONMENTAL REGULATIONS

The Group's operations are minimally affected by environmental regulations.

NEW ACCOUNTING STANDARDS FOR APPLICATION IN FUTURE PERIODS

The AASB has issued a number of new and amended Accounting Standards and Interpretations that have mandatory application dates for future reporting periods, some of which are relevant to the Group.

The Group has decided not to early adopt any of the new and amended pronouncement as the Group assessed that the new and amended pronouncements have no material impact on the Group.

He also set up a franchise business in the USA 2002 – 2005.

Extremely adept at dealing with businesses and consumers alike, he co-established the Business Brokerage Division at Bayley's Real Estate – one of the largest real estate and business brokerages in New Zealand, where he was twice awarded the "Salesman of the Year" award.

He has also been a commercial flying instructor and Airline pilot, having flown commuter planes for Eagle Air, owned by Air New Zealand.

affect the Group financial performance. Laws and regulations are specific to each geographic location. In this regard, there is a risk that a certain product may not be able to be supplied in another jurisdiction because it fails to meet that jurisdiction's regulatory requirements (e.g. product registration requirements).

Failure of the Group to remain up to date with these various regulatory requirements could adversely affect the Group's financial performance.

NOTES TO THE FINANCIAL STATEMENTS

1. NATURE OF OPERATIONS

Zoono Group Limited and Subsidiaries (the Group) principal activities included the research, development and sale of a range of antimicrobial products in multiple countries.

2. GENERAL INFORMATION AND STATEMENT OF COMPLIANCE

The consolidated financial statements are a general-purpose financial report that has been prepared in accordance with Australian Accounting Standards, Australian Accounting Interpretations, other authoritative pronouncements of the Australian Accounting Standards Board and the Corporations Act 2001. Compliance with Australia Accounting Standards results in full compliance with the International Financial Reporting Standards ('IFRS') as issued by the International Accounting Standards Board (IASB). For the purposes of preparing the Consolidated Financial Statement, the Company is a for-profit entity.

Zoono Group Limited (the Company) is the Ultimate Parent Company. Zoono Group Limited is a Public Company incorporated in Australia and domiciled in New Zealand. The Company registered address is Level 8, 210 George Street Sydney NSW 2000 Australia.

The Consolidated financial statements of the Group as at and for the year ended 30 June 2025 comprise the Company and its subsidiaries (together referred to as the 'Group' or 'Consolidated entity'). The consolidated financial statements for the year ended 30 June 2025 were approved and authorised for issue by the board of Directors on 28 August 2025.

Except for cash flow information, the consolidated financial statements have been prepared on an accrual basis and are based on historical costs modified, where applicable, by the measurements at fair value of selected non-current assets, financial assets and financial liabilities.

Going Concern

Notwithstanding the group incurred a loss after tax of \$3,926,090 and net cash outflows from operating activities of \$1,701,601 for the year ended 30 June 2025, the financial report has been prepared on the going concern basis, which assumes the continuity of normal business activities and the realisation of assets and settlement of liabilities in the ordinary course of business.

In making this assessment, the directors have considered:

- The group held cash and cash equivalents of \$51,071 as at 30 June 2025;
- The plans and forecasts reviewed by the directors for the next twelve months anticipate the business will continue to produce improved results;
- Effective working capital management including the ability to control and scale back any expenditures and commitments to conserve cash resources if required.
- Following the recent non-renounceable rights issue in June 2025, and under the shortfall offer in the rights issue, the Company has been able to place in August 2025 the entire shortfall number of 28,349,219 shares at A\$0.035 raising a further A\$992,223 in working capital and bringing in the total amount raised under the rights issue of A\$1.78m.

The directors therefore are of the opinion that the group will be able to pay its debts as and when they become due and payable, and no asset is likely to be realised for an amount less than the amount at which it is recorded in the financial report.

Accordingly, no adjustments have been made to the financial report relating to the recoverability and

classification of recorded asset amounts or to the amounts and classification of liabilities that might be necessary should the group not continue as a going concern.

Statement of Cash Flows

The statement of cash flows comprises the cash balances of Zoono Group Limited and its subsidiaries at the beginning of the financial year, and the cash transactions of the consolidated Group for the 12 month period.

3. CHANGES IN ACCOUNTING POLICIES

New Accounting Standards for application in future periods

The AASB has issued a number of new and amended Accounting Standards and Interpretations that have mandatory application dates for future reporting periods, some of which are relevant to the Group. The Group has decided not to early adopt any of the new and amended pronouncements as the Group assessed that the new and amended pronouncements have no material impact on the Group.

4. MATERIAL ACCOUNTING POLICIES

The following significant accounting policies have been adopted in the preparation and presentation of the financial report.

(a) General

Material accounting policies adopted in the preparation of this financial report are presented below and have been consistently applied unless otherwise stated.

Reporting basis and conventions

These financial statements have been prepared on an accruals basis under the historical cost convention.

Critical accounting estimates and judgements

The preparation of a financial report in conformity with Australian Accounting Standards requires management to make estimates, judgements and assumptions based on historical knowledge and best available current information. Estimates assume a reasonable expectation of future events and are based on current trends and economic data obtained both externally and within the Group. Actual results may differ from the estimates.

IMPAIRMENT

In assessing impairment, management estimates the recoverable amount of each asset or cash generating unit based on expected future cash flows and, where required, uses an interest rate to discount them.

Estimation uncertainty relates to assumptions about future operating results and the determination of a suitable discount rate.

INVENTORIES

Management estimates the net realisable values of inventories, taking into account the most reliable evidence available at each reporting date. The future realisation of these inventories may be affected by future technology or other market-driven changes that may reduce future selling prices.

(b) Basis of Consolidation

The consolidated financial statements incorporate all of the assets, liabilities and results of Zoono Group Limited and all subsidiaries as at 30 June 2025.

Subsidiaries are all entities over which the Group has control. The Group controls an entity when it is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power to direct the activities of the entity.

The assets, liabilities and results of all subsidiaries are fully consolidated into the financial statements of the Group from the date on which control is obtained by the Group.

The consolidation of a subsidiary is discontinued from the date that control ceases.

Intercompany transactions, balances and unrealised gains or losses on transactions between group entities are fully eliminated on consolidation.

Accounting policies of subsidiaries have been changed and adjustments made where necessary to ensure uniformity of the accounting policies adopted by the Group.

(c) Business Combinations

The Group applies the acquisition method in accounting for business combinations. The consideration transferred by the Group to obtain control of a subsidiary is calculated as the sum of the acquisition-date of fair values of assets transferred, liabilities incurred and the equity interests issued by the Group, which includes the fair value of any asset or liability arising from a contingent consideration arrangement. Acquisition costs are expensed as incurred.

The Group recognises identifiable assets acquired and liabilities assumed in a business combination regardless of whether they have been previously recognised in the acquiree's financial statements prior to the acquisition. Assets acquired and liabilities assumed are generally measured at their acquisition-date fair values.

Goodwill is stated after separate recognition of identifiable intangible assets. It is calculated as the excess of the sum of: (a) fair value of consideration transferred, (b) the recognised amount of any non-controlling interest in the acquiree, and (c) acquisition-date fair value of any existing equity interest in the acquiree, over the acquisition-date fair values of identifiable net assets. If the fair values of identifiable net assets exceed the sum calculated above, the excess amount (i.e. gain on a bargain purchase) is recognised in profit or loss immediately.

(d) Foreign Currency Transactions and Balances Functional and presentation currency

The functional currency of each of the Group entities is measured using the currency of the primary economic environment in which that entity operates.

The consolidated financial statements are presented in New Zealand dollars, which is the parent entity's functional and presentation currency.

Transactions and balances

Foreign currency transactions are translated into functional currency using the exchange rates prevailing at the date of the transaction. Foreign currency monetary items are translated at the year-end exchange rate. Non-monetary items measured at historical cost continue to be carried at the exchange rate at the date of the transaction. Non-monetary items measured at fair value are reported at the exchange rate at the date when fair values were determined.

Exchange differences arising on the translation of monetary items are recognised in profit or loss, except where deferred in equity as a qualifying cash flow or net investment hedge.

Exchange differences arising on the translation of non-monetary items are recognised directly in other comprehensive income to the extent that the underlying gain or loss is recognised in other comprehensive income; otherwise, the exchange difference is recognised in profit or loss.

Group companies

The financial results and position of foreign operations whose functional currency is different from the Group's presentation currency is translated as follows:

- Assets and liabilities are translated at year end exchange rates prevailing at that reporting date.
- Income and expenses are translated at average exchange rates for the year.
- Retained earnings/Accumulated losses are translated at the exchange rates prevailing at the date of the transaction.

Exchange differences arising on translation of foreign operations with functional currencies other than the Australian dollar are recognised in other comprehensive income and included in the foreign currency translation reserve in the statement of financial position. The cumulative amount of these differences is reclassified into profit or loss in the period in which the operation is disposed of.

(e) Cash and cash equivalents

Cash and cash equivalents includes cash on hand, deposits held at call with banks and other short-term highly liquid investments with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

(f) Income Tax

The charge for current income tax expense is calculated by reference to the amount of income taxes payable or recoverable in respect of the taxable profit or loss for the period. It is calculated using the tax rates that have been enacted or are substantially enacted by the reporting date.

Deferred tax is accounted for using the liability method in respect of temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the financial statements. No deferred income tax will be recognised from the initial recognition of an asset or liability, excluding a business combination, where there is no effect on accounting or taxable profit or loss.

Deferred tax is calculated at the tax rates that are expected to apply to the period when the asset is realised, or liability is settled. Deferred tax is charged to the statement of profit or loss and other comprehensive income except where it relates to items that may be credited directly to equity, in which case the deferred tax is adjusted directly against equity.

Deferred income tax assets are recognised to the extent that it is probable that future tax profits will be available against which deductible temporary differences can be utilised.

Current tax assets and liabilities are offset where a legally enforceable right of set-off exists and it is intended that net settlement or simultaneous realisation and settlement of the respective asset and liability will occur. Deferred tax assets and liabilities are offset where a legally enforceable right of set-off exists, the deferred tax assets and liabilities relate to income taxes levied by the same taxation authority on either the same taxable entity or different taxable entities where it is intended that net settlement or simultaneous realisation and settlement of the respective asset and liability will occur in future periods in which significant amounts of deferred tax assets or liabilities are expected to be recovered or settled.

The amount of benefits brought to account or which may be realised in the future is based on the assumption that no adverse change will occur in income taxation legislation and the anticipation that the consolidated entity will derive sufficient future assessable income to enable the benefit to be realised and comply with the conditions of deductibility imposed by the law.

(g) Inventories

Inventories are measured at the lower of cost and net realisable value. The cost of manufactured products includes direct materials, direct labour and an appropriate proportion of variable and fixed overheads. Overheads are applied on the basis of normal operating capacity. Costs are assigned on a first-in, first-out basis. Net realisable value is the estimated selling price in the ordinary course of business less any applicable selling expenses.

(h) Plant and equipment

Plant and equipment are measured on the cost basis less accumulated depreciation and impairment losses.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably.

All other repairs and maintenance are charged to the profit or loss during the financial period in which they are incurred. All fixed assets are depreciated over their estimated useful lives to the Group.

The depreciation rates used for each class of depreciable assets are:

Depreciation

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at each reporting date. An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains and losses are included in the profit or loss within other income or expenses.

(i) Intangible Assets

Patents, trademarks and website development are recognised at cost of acquisition. They have a finite life and are carried at cost less any accumulated amortisation and any impairment losses. Patents, trademarks and website development are amortised over their useful lives of up to 10 years. Amortisation has been included within depreciation, amortisation and impairment of non-financial assets.

(j) Impairment of Assets

At the end of each reporting period, the Group assesses whether there is any indication that an asset may be impaired. The assessment will include considering external sources of information and internal sources of information including dividends received from subsidiaries, associates or joint ventures deemed to be out of pre-acquisition profits. If such an indication exists, an impairment test is carried out on the asset by comparing the recoverable amount of the asset, being the higher of the asset's fair value less costs of disposal and value in use, to the asset's carrying amount. Any excess of the asset's carrying amount over its recoverable amount is recognised immediately in profit or loss, unless the asset is carried at a re-valued amount.

Any impairment loss of a revalued asset is treated as a revaluation decrease. Where it is not possible to estimate the recoverable amount of an individual asset, the Group estimates the recoverable amount of the cash-generating unit to which the asset belongs. Impairment testing is performed annually for goodwill and intangible assets.

(k) Fair Value of Assets and Liabilities

The Group measures some of its assets and liabilities at fair value on either a recurring or non-recurring basis, depending on the requirements of the applicable Accounting Standard.

Fair value is the price the Group would receive to sell an asset or would have to pay to transfer a liability in an orderly (i.e. unforced) transaction between independent, knowledgeable and willing market participants at the measurement date.

As fair value is a market-based measure, the closest equivalent observable market pricing information is used to determine fair value. Adjustments to market values may be made having regard to the characteristics of the specific asset or liability. The fair values of assets and liabilities that are not traded in an active market are determined using one or more valuation techniques.

These valuation techniques maximise, to the extent possible, the use of observable market data.

To the extent possible, market information is extracted from either the principal market for the asset or liability (i.e. the market with the greatest volume and level of activity for the asset or liability) or, in the absence of such a market, the most advantageous market available to the entity at the end of the reporting period (i.e. the market that maximises the receipts from the sale of the asset or minimises the payments made to transfer the liability, after taking into account transaction costs and transport costs).

For non-financial assets, the fair value measurement also takes into account a market participant's ability to use the asset in its highest and best use or to sell it to another market participant that would use the asset in its highest and best use.

The fair value of liabilities and the entity's own equity instruments (excluding those related to share-based payment arrangements) may be valued, where there is no observable market price in relation to the transfer of such financial instruments, by reference to observable market information where such instruments are held as assets.

Where this information is not available, other valuation techniques are adopted and, where significant, are detailed in the respective note to the financial statements.

(l) Accounts payable

Trade payables and other accounts payable are recognised when the Group becomes obliged to make future payments resulting from the purchase of goods and services. Due to their short-term nature, they are measured at amortised cost and not discounted. These amounts are unsecured and are usually paid within 30 days of recognition.

(m) Provisions

Provisions are recognised when the Group has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result, and that outflow can be reliably measured.

Provisions are measured using the best estimate of the amounts required to settle the obligation at the end of the reporting period.

(n) Financial Instruments

Financial assets and financial liabilities are recognised when the Group become a party to the contractual provisions of the financial instrument.

Financial assets are derecognised when the contractual rights to the cash flows from the financial asset expire, or when the financial asset and substantially all the risk and rewards are transferred. A financial liability is derecognised when it is extinguished, discharged, cancelled or expires.

Classification and initial measurement of financial assets

Financial assets are classified into one of the following categories:

- Fair value through profit or loss (FVTPL), or
- Fair value through other comprehensive income (FVOCI)

The classification is determined by both:

- The entity's business model for managing the financial asset, and
- The contractual cash flow characteristics of the financial asset.

All revenue and expenses relating to financial assets that are recognised in profit or loss are presented within finance costs, finance income or other financial items, except for impairment of trade receivables which is presented within administration expenses.

In the periods presented the Group does not have any financial assets categorised as FVTPL and FVOCI.

Financial assets at amortised cost

Financial assets are measured at amortised cost if the asset meet the following condition (and are not designated as FVTPL):

They are held within a business model whose objective is to hold the financial assets and collect its contractual cash flows, and

The contractual terms of the financial assets give rise to cash flows that are solely payment of principal and interest on the principal amount outstanding.

After initial recognition, these are measured at amortised cost using the effective interest method.

Discounting is omitted where the effect of discounting is immaterial.

Impairment of financial assets

The Group makes use of a simplified approach in accounting for trade and other receivables as well as contract assets and records the loss allowance as lifetime expected credit losses. These are the expected shortfalls in contractual cash flows, considering the potential for default at any point during the life of the financial instrument. In calculating, the Group uses its historical experience, external indicators and forward-looking information to calculate the expected credit losses using a provision matrix.

The Group assess impairment of trade receivables on a collective basis as they possess shared credit risk characteristics they have been grouped based on the days past due.

Classification and measurement of financial liabilities

The Group's financial liabilities include borrowings, trade and other payables and contract liabilities.

Financial liabilities are initially measured at fair value, and, where applicable, adjusted for transaction costs unless the Group designated a financial liability at fair value through profit or loss.

Subsequently, financial liabilities are measured at amortised cost using the effective interest method except for derivatives and financial liabilities designated at FVTPL, which are carried subsequently at fair value with gain or losses recognised in profit or loss (other than derivative financial instruments that are designated and effective as hedging instruments).

All interest-related charges and, if applicable, changes in an instrument's fair value that are reported in profit or loss are included within finance costs or finance income.

(o) Receivables

Trade receivables are initially recognised at fair value and subsequently measured at amortised cost using the effective interest method, less any allowance for impairment.

(p) Employee Benefits

Short-term employee benefits

Provision is made for the Group's obligation for short-term employee benefits. These benefits are benefits (other than termination benefits) that are expected to be settled wholly before 12 months after the end of the annual reporting period in which the employees render the related service, including wages, salaries and sick leave. Short-term employee benefits are measured at the (undiscounted) amounts expected to be paid when the obligation is settled.

The Group's obligations for short-term employee benefits such as wages, salaries and sick leave are recognised as part of current trade and other payables in the statement of financial position.

(q) Share-based payments

The cost to the Company of share options granted to directors and executive officers is included at fair value as part of the directors' and executive officers' aggregate remuneration in the financial year the options are granted.

The fair value of the share option are calculated using the Black Scholes option pricing model, which takes into account the exercise price, the term of the option, the vesting and performance criteria, the impact of dilution, the non-tradable nature of the option, the current price and expected price volatility of the underlying share, the expected dividend yield and the risk-free interest rate for the term of the option.

The fair value determined at the grant date of the equity settled share-based payment is expensed

on a straight-line basis over the vesting period.

(r) Revenue

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. Any consideration deferred is treated as the provision of finance and is discounted at a rate of interest that is generally accepted in the market for similar arrangements. The difference between the amount initially recognised and the amount ultimately received is interest revenue.

Revenue from the sale of goods is recognised when the removal from the warehouse occurs as this corresponds to the transfer of significant risks and rewards of ownership of the goods and the cessation of all involvement by the Group in those goods.

All revenue is stated net of the amount of goods and services tax.

Other income

Interest revenue is recognised using the effective interest method, which for floating rate financial assets is the rate inherent in the instrument.

Dividend revenue is recognised when the right to receive a dividend has been established.

Realised gains and losses on sale are recognised as income or expense respectively in the statement of profit or loss and other comprehensive income and are calculated as the difference between consideration on sale and the original cost.

(s) Goods and services tax (GST)

The Statement of Profit or Loss and Other Comprehensive Income has been prepared so that all components are stated exclusive of GST, except where the amount of GST incurred is not recoverable from the tax office. All items in the Statement of Financial Position are stated exclusive of GST, with the exception of receivables and payables, which include GST.

(t) Earnings per share

i) Basic earnings per share:

Basic earnings per share is determined by dividing the operating loss after income tax excluding any cost of servicing equity other than ordinary shares by the weighted average number of ordinary shares outstanding during the financial year.

ii) Diluted earnings per share

Diluted earnings per share adjusts the figures used in determining earnings per share by taking into account amounts unpaid on ordinary shares and any reduction in earnings per share that will probably arise from the exercise of options outstanding during the financial year.

(u) Segment reporting

Segment revenues and expenses are those directly attributable to the segments and include any joint revenue and expenses where a reasonable basis of allocation exists. Segment assets include all assets used by a segment and consist principally of cash, receivables, inventories, intangibles and property, plant and equipment, net of allowances and accumulated depreciation and amortisation. Segment liabilities consist principally of payables, employee benefits, accrued expenses, provisions and borrowings. The Group do not allocate revenues, assets or liabilities to individual segments.

(v) Leases

At inception of a contract, the Group assesses if the contract contains or is a lease. If there is a lease present, a right-of-use asset and a corresponding lease liability is recognised by the Group where the Group is a lessee. However, all contracts that are classified as short-term leases (i.e. a lease with a remaining lease term of 12 months or less) and leases of low-value assets are recognised as an operating expense on a straight-line basis over the term of the lease.

Initially, the lease liability is measured at the present value of the lease payments still to be paid at commencement date. The lease payments are discounted at the interest rate implicit in the lease. If this rate cannot be readily determined, the Group uses the incremental borrowing rate.

The right-of-use assets comprise the initial measurement of the corresponding lease liability as mentioned above, any lease payments made at or before the commencement date, as well as any initial direct costs. The subsequent measurement of the right-of-use assets is at cost less accumulated depreciation and impairment losses.

Right-of-use assets are depreciated over the lease term or useful life of the underlying asset, whichever is shorter. Where a lease transfers ownership of the underlying asset, or the cost of the right-of-use asset reflects that the Group anticipates to exercise a purchase option, the specific asset is depreciated over the useful life of the underlying asset.

(w) Comparative information

Comparative figures are, where appropriate, reclassified to be comparable with the figures presented for the financial year.

Provision for employee benefits

Provision for employee benefits represents amounts accrued for annual leave.

The current portion for this provision includes the total amount accrued for annual leave entitlements that have vested due to employees having completed the required period of service. Based on past experience, the Group does not expect the full amount of annual leave balances classified as current liabilities to be settled within the next 12 months. However, these amounts must be classified as current liabilities since the Group does not have an unconditional right to defer the settlement of these amounts in the event employees wish to use their leave entitlement.

Provision for contingent consideration

With the major downturn in the Company's business in the US, the Company has successfully re-negotiated its agreement back in June 2020 pursuant to which it bought back the US business from its US distributor, Zoono USA LLC.

The following points have been agreed:

- US\$850,000 is the new amount owing to Zoono USA LLC from the original MOU purchase amount of US\$4,000,000.
- Ownership of Zoono USA LLC moves from 10% to Nil. Zoono Holdings USA LLC will own 100% of the company.
- Zoono Holdings USA LLC will now pay 10% of USA gross sales from January 1 2023 on a quarterly basis until the US\$850,000 is extinguished. The payments will be made by 15th of the month following quarter end.

No payment has been made to Zoono USA LLC this financial year (2024: NZ\$64,876).

Management effectively manages the Group capital by assessing the Group's financial risks and adjusting its capital structure in response to changes in these risks and in the market. These responses include the management of share issues. The Group strategy remains unchanged from prior year.

Zoono's Employee Securities Plan (including independent contractors and advisors) was adopted by the Company on 7 November 2019 as a long-term incentive scheme to recognise talent, retain and motivate employees to strive for Group performance. All employees are entitled to participate in the Share Securities Plan. In 2022, employees and consultants who have been with the Group for more than one year were invited to receive options which vest in 1-3 years, provided the recipient is still employed by the Company. The options were issued for no consideration with an exercise price of A\$0.35. They carry no entitlements to voting rights or dividends of the Group. The number available to be granted is determined by the Board, based on retention, performance measures including growth in shareholder return, return on equity, cash earnings and Group earnings per share growth.

Option granted to employees of the Company

On 30 September 2022, Zoono granted senior management and staff 4,200,000 options, vesting on 30 September 2023 through to 30 September 2025, exercisable at A\$0.35 and expiring on 30 September 2025 and 30 September 2026. The total fair value of the options granted were NZ\$147,922.

As part of the rights issue in June 2023, free attaching options of 7,248,264 were issued to shareholders, and shareholder employees of the Group. These are unlisted options exercisable at A\$0.10 expiring on 2 June 2026. The total value is NZ\$103,802.

As part of the underwriting agreement with Evolution Capital Pty Ltd dated 22 March 2024 for the non-renounceable rights issue at the time, Evolution were provided with broker options of 10,000,000 options with 5,000,000 options at an exercise price of A\$0.05 expiring on 25 November 2026 and 5,000,000 options at an exercise price of A\$0.10 expiring on 25 November 2027. The total fair value is NZ\$56,200.

During the year, no options were exercised. The Group has 27,301,598 share options on issue at year end (2024: 17,301,598).

20. ECONOMIC DEPENDENCY

Zoono and its products are subject to various laws and regulations including but not limited to accounting standards, tax laws, environmental laws, product content requirement, labelling/ packaging, regulations and customs regulations. Changes in these laws and regulations (including

interpretation and enforcement) could adversely affect the Group's financial performance. Laws and regulations are specific to each geographic location. In this regard, there is a risk that a certain product may not be able to be supplied in another jurisdiction because it fails to meet that jurisdiction's regulatory requirements (e.g. product registration requirements). Failure of the Group to remain up to date with these various regulatory requirements, could adversely affect the Group financial performance.

21. CONTINGENT LIABILITIES

The directors are aware of a claim against the Company as at the date these financial statements are signed, are made up as follows:

- The Company is currently being prosecuted by the Commerce Commission for allegedly unsubstantiated representations made about its hand sanitiser and microbe shield surface spray contrary to section 12A of the Fair Trading Act 1986. Zoono believes it has complied fully with its legal obligations and intends to strenuously defend the action. Zoono's public representations concerning the efficacy and durability of its products have been made in reliance of over 200 independent tests undertaken by laboratories worldwide in accordance with recognised standards. The Court case is set down for 4 May 2026.

28. FINANCIAL RISK MANAGEMENT

Financial risk management policies

The Group's financial instruments consist mainly of current accounts with banks, accounts receivable and payable.

i) Treasury risk management

Management considers on a regular basis the financial risk exposure and evaluates treasury management strategies in the context of the most recent economic conditions and forecasts.

The overall risk management strategy seeks to meet the Group's financial targets, whilst minimising potential adverse effects on financial performance.

Management operates under policies approved by the board of directors which approves and reviews risk management policies on a regular basis. These include future cash flow requirements.

ii) Financial risk exposures and management

The main risks the Group is exposed to through its financial instruments are interest rate risk, foreign currency risk, liquidity risk, credit risk and price risk.

(a) Foreign currency risk exposure

Most of the Group's transactions are carried out in US Dollars (\$USD), New Zealand Dollars (\$NZD), Australian Dollars (\$AUD) and British Pound (GBP). Exposures to currency exchange rates arise from the Group's overseas sales and purchases, which are primarily denominated in US Dollars (\$USD), Australian Dollars (\$AUD) and British Pound (GBP). The Group also holds a bank account in \$USD, \$AUD, Rand, GBP and RMB.

(b) Interest rate risk exposure

The Group is exposed to interest rate risk through cash and deposits held. The Group continually monitors interest rates and financial markets for the Group's cash on deposit and regularly reviews future cash flow requirements.
