

NOTICE PURSUANT TO SECTION 708A(5)(E) OF THE CORPORATIONS ACT

Lindian Resources Limited (ASX:LIN) ("the Company") gives notice pursuant to section 708A(5)(e) of the Corporations Act 2001 Cth ('the Act') that on 2 September 2025, it has issued a total of 381,863 fully paid ordinary shares at \$0.21 in relation to tranche 1 of a placement announced on 20 August 2025.
